	Between 1993 and 2004, the General Assembly has authorized the expenditure of over \$500,000 to "assemble and make available to water users in Colorado a consolidate water resources information center (WRIC)" (Sec. 6, HB93-1273). Using this authority, and in combination with the CWCB data imaging project, office space was leased at 1580 Logan Street (the same building where the Colorado Water Congress and the Colorado Foundation for Water Education are located) to house the WRIC.					

To further the goal of making a truly accessible and useful WRIC, the CWCB is investigating how to make access to online, water resources information easier. The ability to search multiple water information collections has not yet been made possible, which is a challenge this project looks to overcome. By establishing a standard protocol to search for and retrieve electronic information (documents, reports, maps, data, historic records, etc.), users statewide could use the system with which they are most familiar, and obtain documents from numerous providers, saving time and ultimately money. The initial implementation of the protocol would be between CWCB and CSU, with the intention of adding other interested entities. The project would also provide some funding for furthering CSU's digitization of documents, such as the Delph Carpenter papers.
