Stream and Lake Protection Section – 2008 Instream Flow Appropriations

Summary

TO:

At its January 27, 2009 meeting, the Board declared its intent to appropriate 19 instream flow water rights. The purpose of this agenda item is to provide notice to the public of the 19 proposed instream flow appropriations and to provide an opportunity for public comment pursuant to ISF Rule 5e.

No Board action is required.

Background

Public comment will be taken on the following instream flow water right appropriations being considered by the Board. The Board noticed these proposed appropriations in March and November 2008 and declared its intent to appropriate at its January 27, 2009 meeting.
