The CWCB holds the following instream flow water rights that could be injured by this application:

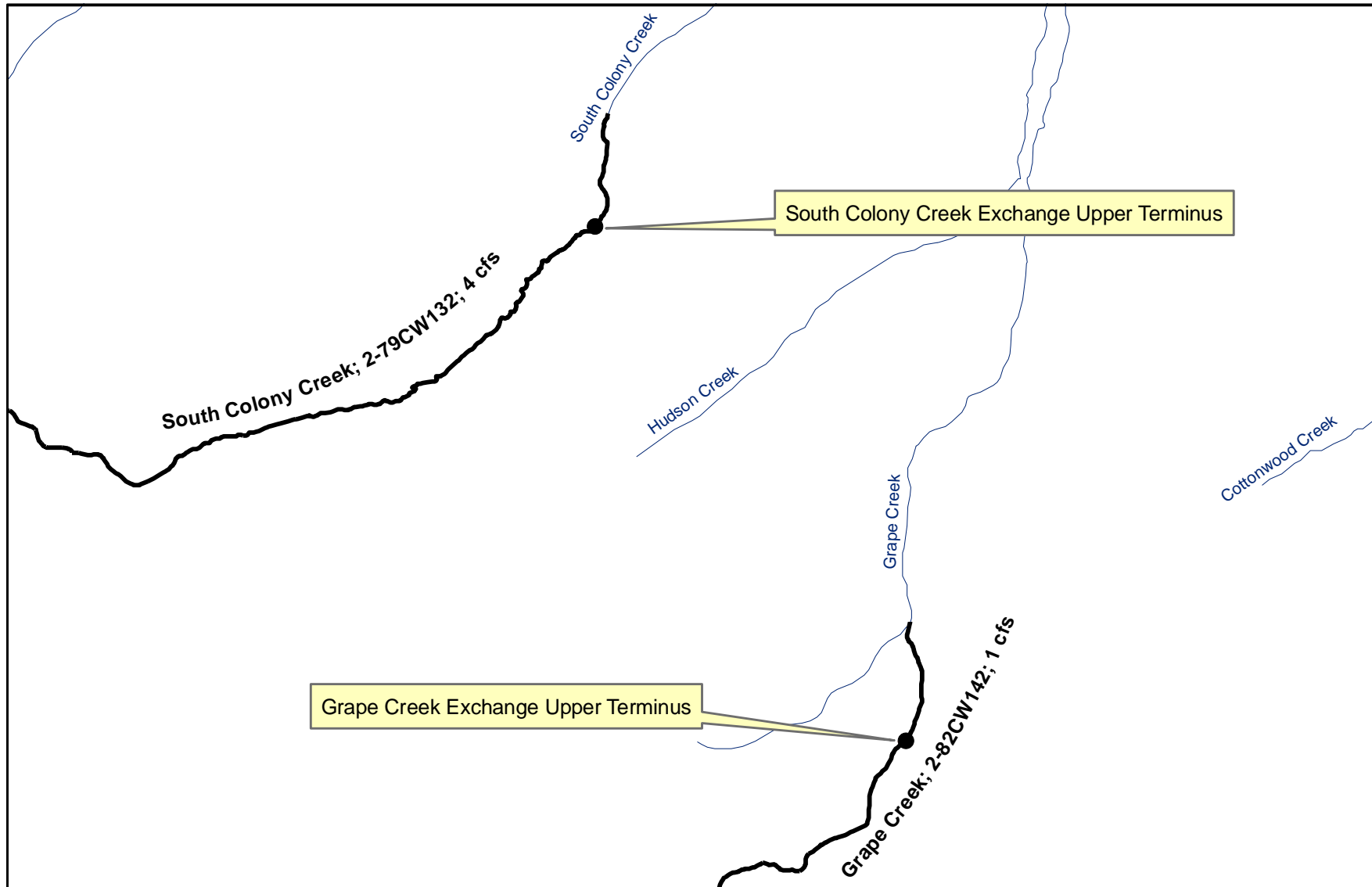
