WHEREAS, Daniel L. Law has been the Executive Director of the Colorado Water Resources and Power Development Authority for nearly 20-years; and,

WHEREAS, prior to starting to work for the Authority in 1984 Daniel L. Law he worked for the Colorado Water Conservation Board, the Denver Regional Council of Governments and the URS Corporation; and,

WHEREAS, Under Daniel L. Law leadership, the Authority's mission evolved from assisting in the planning and development of water projects to the administration of the State Revolving Funds authorized by the federal Clean Water and Safe Drinking Water Acts; and,

WHEREAS, Under Daniel L. Law leadership, the Authority led the way in development of additional loan programs outside of federal funding, including the Small Water Resources Projects Program and most recently, the Small Hydropower Loan Program; and,

WHEREAS, Daniel L. Law was responsible for the execution of 386 loans, resulting in distribution of over \$1.7 billion dollars in loan funds for the development of water and wastewater projects throughout the State of Colorado; and,

WHEREAS, Daniel L. Law was instrumental in assisting in the development and implementation of funding for key components of the Animas-La Plata Project and funding for Stagecoach and Fish Creek Reservoirs; and,

WHEREAS, Daniel L. Law continues to be actively involved in the community, and is currently the President of the Council of Infrastructure Financing Authorities, President of the Archdiocesan Housing Committee and the President of the Hampden Heights Civic Association; and,

WHEREAS, Daniel L. Law served as an invaluable resource to members of the Colorado Water Conservation Board, providing regular updates, counsel and friendship;
