#### Summary

This informational memo provides an update on the proposed instream flow recommendation on the San Miguel River. In addition, Harris Engineering will provide the Board with a status report on a future water needs analysis for the San Miguel Watershed. No Board action is necessary.

#### Background

At the January 2010 meeting, staff presented the Board with an overview of the San Miguel River ISF recommendation that it had received from both the Colorado Division of Wildlife and the Bureau of Land Management. In addition, staff presented its analyses and the information necessary for the Board to form its intent to appropriate ISF water rights for the recommended segment (See attached table).

The San Miguel River recommendation has received attention from numerous stakeholders including San Miguel and Montrose Counties, the San Miguel Governmental Task Force, the Southwestern Water Conservation District (SWCD), numerous environmental interests and local water users. Because of the extensive discourse that has been occurring with respect to these recommendations, the Board elected not to form its intent to appropriate at the January Meeting. Rather, it delayed action until January 2011 if the stakeholders demonstrate significant progress with regard to assessing projected water supply needs and evaluating projects and management options to meet future needs. In addition, the Board requested a presentation from SWCD's engineer at the May 2010 meeting. Harris Engineering has sent staff regular status reports and will provide the Board with a detailed update on activities at this Board meeting.
