Prehearing Statement of the Colorado Division of Wildlife

IN THE MATTER OF PROPOSED INSTREAM FLOW APPROPRIATIONS ON THE
HUERFANO RIVER (UPPER AND LOWER SEGMENTS), in WATER DIVISION 2

Pursuant to Rule 5n of the Rules Concerning the Colorado Instream Flow and Natural Lake Levels, 2 CCR 408-2 (“ISF Rules”), the Colorado Division of Wildlife (“CDOW”) hereby submits its prehearing statement in support of the Colorado Water Conservation Board (“CWCB”) Staff’s recommendations for instream flow (“ISF”) appropriations on the subject reaches (upper and lower segments) of the Huerfano River and in the amounts set forth in CWCB staff recommendation (*see* CWCB staff recommendations at www.cwcb.state.co.us).

A. FACTUAL CLAIMS

1) Pursuant to Title 33 of the Colorado Revised Statutes (CRS):

§33-1-101 – “It is the policy of the state of Colorado that the wildlife and their environment are to be protected, preserved, enhanced, and managed for the use, benefit, and enjoyment of the people of this state and its visitors ... that there shall be provided a comprehensive program designed to offer the greatest possible variety of wildlife-related recreational opportunity to the people of this state and its visitors and that, to carry out such program and policy, there shall be a continuous operation of planning, acquisition, and development of wildlife habitats and facilities for wildlife related opportunities.”

§33-2-102 – “... it is the policy of this state to manage all nongame wildlife, recognizing the private property rights of individual property owners, for human enjoyment and welfare, for scientific purposes, and to insure their perpetuation as members of ecosystems; that species or subspecies of wildlife indigenous to this state which may be found to be endangered or threatened within the state should be accorded protection in order to maintain and enhance their numbers to the extent possible ...”

§33-2-106 – “(1) The division [of Wildlife] shall establish such programs including acquisition of land or aquatic habitat as are deemed necessary for management of nongame, endangered, or threatened wildlife. (2) ... the division may enter into agreements with federal agencies or political subdivisions of this state or with private persons for administration and management of any area established under this section or utilized for management of nongame, endangered, or threatened wildlife.”

§33-5-101 – “It is declared to be the policy of the state that its fish and wildlife resources, and particularly the fishing waters within the state, are to be protected and preserved from the actions of any state agency to the end that they be available for all time and without change in their natural existing state, except as may be necessary and appropriate after due consideration of all factors involved.”

- 2) Based upon field surveys conducted by the CDOW, CDOW concludes that there is a natural environment that can be preserved on the subject reaches of the Huerfano River.
- 3) The natural environment on the subject reaches of the Huerfano River: (a) will be preserved to a reasonable degree with the proposed ISF water right; and, (b) can exist without material injury to water rights.
- 4) The Huerfano River satisfies criteria identified by the CWCB for ISF appropriations, including:
 - a) The recommendations have broad public support;
 - b) The proposed appropriations will have a positive impact on state or local economies;
 - c) The recommendations are part of a water acquisition strategy; and
 - d) The recommendations are part of a collaborative solution to a unique natural resource issue with federal, state or local partners.
- 5) The instream flow amount and timing recommended by the CWCB staff:
 - a) Is based upon standard scientific methodology and an accurate R2CROSS analysis;
 - b) Reflects the amount of water available for appropriation as an instream flow water right; and
 - c) Is required to preserve the natural environment to a reasonable degree.

B. LEGAL CLAIMS

CDOW is not submitting legal claims with this prehearing statement, but reserves the right to submit legal claims with its rebuttal statement.

C. EXHIBITS TO BE INTRODUCED AT HEARING

- 1) January 2009 CWCB Staff Reports on the upper and lower segments of the Huerfano River. These reports contain maps and photographs of the proposed reaches, information regarding the proposed ISF amounts, data collected by CDOW up to the date of the reports, hydraulic and hydrologic studies, and water availability estimates (*see* CWCB staff recommendations at www.cwcb.state.co.us).
- 2) CDOW may introduce demonstrative exhibits as allowed by the CWCB or as otherwise agreed upon by the Parties.
- 3) CDOW may introduce demonstrative or other exhibits for rebuttal purposes as allowed by the CWCB or as otherwise agreed upon by the Parties.

D. WITNESSES

The following witnesses may testify at the hearing in the capacities as described below, may give rebuttal testimony, and may be available at the hearing to answer questions from the Board.


