## **Staff Recommendation**

This is an *information* item and Board action is not required.

## Background

In November, 2009 the Arkansas Basin Roundtable produced "A Resource Document: Projects and Methods to Meet the Needs of the Arkansas Basin." The Resource Document builds on the Arkansas Basin Roundtable's consumptive and nonconsumptive needs assessment and identifies both structural and nonstructural projects and methods for meeting the basin's consumptive and nonconsumptive needs.

The Arkansas Basin Roundtable identified the following <u>projects</u> as important for meeting their future water supply needs:

- 1. Development of an Arkansas Decision Support System along with the Upper Ark Conservancy water monitoring devices
- 2. The Preferred Storage Option Plan for expansion of Pueblo Reservoir
- 3. The Southern Delivery System
- 4. The Arkansas Valley Conduit component of the Frying Pan/Arkansas Project
- 5. State Parks Zebra Mussel response
- 6. Fountain Creek flood control and mitigation.
- 7. Arkansas headwaters diversion improvement (increase boater safety)

The Arkansas Basin Roundtable also identified the following <u>methods</u> as important for meeting their future water supply needs:

- 1. The Voluntary Flow Agreement
- 2. Municipal conservation
- 3. Non-native phreatophyte removal
- 4. Rotating agricultural fallowing
- 5. Vision task force
- 6. Underground water storage, both alluvial and deep aquifer
