The Finance Section compiles a list of prequalified projects for the Water Project Loan Program. In order to be included on this list, potential borrowers must submit a Loan Application and two years of financial statements to the CWCB staff. In addition, Borrowers requesting to be placed on the Prequalification Project List have a defined project, have performed preliminary engineering, and have a reasonable estimate of the project costs.

Projects on this list fit the initial criteria of the Water Project Loan Program; however, the list does not constitute loan approval. In order to receive a loan, borrowers must additionally submit a completed Loan Feasibility Study for review by CWCB staff. Staff will then prepare a recommendation to the Board for approval at a future CWCB meeting. Projects will remain on this list for one year from the date of the application or until Board approval of a loan.

Applications received by July 1, 2010 for this board meeting were:

- a. Plains Metro District Water Rights Purchase
- b. Farmers Highline Canal Company Capital Improvement Projects
- c. Huerfano Cucharas Irrigation Company Cucharas Reservoir Dam Rehabilitation




Plains Metropolitan District (District) is located in the Dakota Hogbak/Ken Caryl Ranch area of the Denver Metro area. The District was established to provide for the construction of streets, storm sewer, landscape improvements, and parks and recreation facilities within the District. It is made up of primarily commercial customers and less than 10% residential customers. District revenues are generated from property taxes. The District has no existing debt service. This project involves acquiring water rights to provide irrigation water to Deer Creek Public Golf Course, which the District is in the process of acquiring. The water rights purchase is expected to occur by the end of 2010.

The Farmers High Line Canal and Reservoir Company (Company) is a ditch company that was established in 1885. It diverts water off of clear creek and it delivers water through a 31.5 mile canal running from Golden to Northglenn, through Arvada and Westminster. The Company has completed a master plan and canal evaluation and has identified a list of improvements it intends to do with the CWCB loan proceeds. These items include: replacement of corroded drain pipes, replacement of three siphons, headgate rehabilitation, SCADA control system installation at the headgate, diversion dam rehabilitation, and tree removal along the ditch. This work is expected to be completed over the next three years.

The Huerfano-Cucharas Irrigation Company (Irrigation Company) owns and operates the Cucharas Reservoir and provides irrigation water to farmers in the Arkansas valley. The Irrigation Company was organized in 1944; however, 74% of the shares were recently purchased by Two Rivers Water Company (TRWC). TRWC intends to purchase up to 95% of shares in the Irrigation Company and plans on reintroducing agricultural production to the area. In order to do this, the Cucharas dam must be repaired. The dam is a 145-foot high rock fill dam that has been under storage restriction since 1988. The SEO is requiring the dam to be repaired by October 1, 2010 or a breach order may be imposed. The Irrigation Company plans on rehabilitating the dam, to restore the full storage capacity of the reservoir. The total project investment to repair the dam and reintroduce agricultural production to the area (including land purchased for farming, ditch system repairs, and equipment) is estimated at \$15M. The additional \$5.1M needed for the dam rehabilitation will be paid by Irrigation Company special assessments or additional funding sources. Increases assessments were approved by the Irrigation Company board in April 2010. TRWC is in the process of having an appraisal of the collateral value if a CWCB loan is approved in the future.
