#### FINDINGS OF FACT, CONCLUSIONS OF LAW, RULING OF THE REFEREE JUDGMENT AND DECREE OF THE WATER COURT

This matter comes before the Court by Application of the Colorado Water Conservation Board, Department of Natural Resources, State of Colorado ("CWCB"). The Court, having considered all matters raised by the Application, and being fully advised in the premises, does hereby make the following Findings of Fact, Conclusions of Law, Ruling of the Referee, Judgment and Decree:

# **FINDINGS OF FACT**

1. Name, address and telephone number of Applicant:

2. Applications: CWCB filed an Application for Water Rights to Preserve the Natural Environment to a Reasonable Degree on June 30, 2009.

- 3. Notice and Jurisdiction: All notices of this matter required by law have been fulfilled and the Court has jurisdiction over the Application and all parties affected thereby, whether or not they have chosen to appear.
- 4. Objectors: No statements of opposition were filed. The time for filing statements of opposition has expired.
- 5. Consultation. The Division Engineer filed a Summary of Consultation pursuant to § 37-92-302(4) C.R.S. dated October 19, 2009. The CWCB has addressed the Division Engineer's concerns set forth in the Summary of Consultation.
- 6. Name of Natural Stream. Buzzard Creek, tributary to Plateau Creek, tributary to the Colorado River.
- 7. Location.

- a. Legal description of the stream segment through which an instream flow is claimed: The natural stream channel from the confluence with Willow Creek at latitude 39° 11' 40.59"N and longitude 107° 37' 23.52"W as the upstream terminus and extending to the confluence with Owens Creek at latitude 39° 14' 7.1"N and longitude 107° 37' 57.46"W as the downstream terminus, being a distance of approximately 3.4 miles. This segment can be located on the Porter Mountain and Spruce Mountain U.S.G.S. quadrangles.
- b. For administrative purposes only:

Upper Terminus =

NE NE S14 T10S R92W 6<sup>th</sup> PM 743' South of the North Section Line, 1064' West of the East Section Line UTM North: 4341651.4 UTM East: 273459.8

Note: In the area of the Upper Terminus, the section lines are inconsistent between DWR's AquaMap and BLM mapping, which has updated the sections in this township. The distances from section lines used here are based on DWR standards. The description of the upper terminus based on the updated BLM mapping is NWNW S13 T10S R92W 6<sup>th</sup> PM, 416' East of the West Section Line, 1250' South of the North Section Line.

Lower Terminus =

NW NE S35 T9S R92W 6<sup>th</sup> PM 2247' West of the East Section Line, 468' South of the North Section Line UTM North: 4346192.4 UTM East: 272776.9 8. Use of the water: Instream flow to preserve the natural environment to a reasonable degree.

- 9. Date of appropriation: The water was first applied to the above beneficial use on or before January 27, 2009. The appropriation was completed on January 27, 2009 by the action of the Colorado Water Conservation Board under the provisions of §§ 37-92-102(3) and 37-92-103(3), (4) and (10) C.R.S.
- 10. Amount of water claimed (ABSOLUTE): Instream flow of 4.25 cfs (April 1 August 31) and 1.5 cfs (September 1 March 31).

## **CONCLUSIONS OF LAW**

- 11. Notice and Jurisdiction. The Water Court for Division 5 has jurisdiction over the subject matter of these proceedings and over all persons, owners of property and water rights that may be affected hereby, whether or not they have chosen to appear. The Application in this matter and the resume publication of the Application placed such persons on notice of the relief requested by the application and granted by this decree. §§37-92-203 and 302 C.R.S. (2009).
- 12. The CWCB has fulfilled all legal requirements for a decree for water rights including §§ 37-92-302, 304 and 305, C.R.S. (2009).
- 13. Burden of Proof. The CWCB has complied with all requirements, has met all standards and burdens of proof to adjudicate the water rights requested in the Application and is therefore entitled to a decree approving the requested water rights.

#### JUDGMENT AND DECREE

- 14. The foregoing Findings of Fact and Conclusions of Law are hereby approved and incorporated as the Judgment and Decree of the Court by this reference.
- 15. The Application is granted and the Court hereby approves and decrees the absolute water right described herein, in the amount of 4.25 cfs (April 1 August 31) and 1.5 cfs (September 1 March 31) in order to preserve the natural environment to a reasonable degree in the reach of Buzzard Creek between the upstream and downstream terminus points described in paragraph 7 above. The appropriation date for this water right is January 27, 2009.
- 16. The priority herein awarded was filed in the Water Court in the year of 2009 and shall be junior to all priorities filed in previous years. As between all rights filed in the same calendar year, priorities shall be determined by the historical date of appropriation and not affected by the date of entry of ruling. The applicant shall install and maintain such

measuring devices and keep such records as the Division Engineer may require for administration of this right.

It is accordingly **ORDERED** that this Ruling shall be filed with the water clerk subject to judicial review.

It is further **ORDERED** that a copy of this Ruling shall be filed with the Division Engineer and the State Engineer.
