Summary

At its January 25, 2011 meeting, the Board declared its intent to appropriate 8 instream flow water rights. The purpose of this agenda item is to provide notice to the public of the 8 proposed instream flow appropriations and to provide an opportunity for public comment pursuant to ISF Rule 5e. No Board action is required.

Background
