

Tabulation of Instream Flow Water Rights – 2012

This Tabulation of Instream Flow Water Rights was prepared by the Colorado Water Conservation Board (CWCB), Stream and Lake Protection Section. This Tabulation lists all Instream Flow (ISF) water rights that the Board has appropriated or acquired since the Instream Flow and Natural Lake Level Program's inception in 1973.

Most of the water rights contained in this Tabulation are original appropriations by the CWCB. An amount of 9999 cfs for an ISF appropriation signifies all unappropriated water in the stream segment. Acquired water rights (senior rights that have been donated or otherwise acquired by the CWCB for ISF purposes) are denoted by an asterisk after the case number. The water court case referenced for those acquired rights is the court action to change the water to instream flow use. Acquisitions with the format of **/*/ACQ-** listed as a case number refer to an internal file number because no change of water right was sought by the CWCB.

This tabulation was generated from the CWCB's ISF database, which is separate from the database maintained by the State Engineer's Office for water right administration purposes. The watersheds listed in the Tabulation are derived from the USGS Hydrologic Unit codes (HUC) which are identified at http://water.usgs.gov/wsc/map_index.html

The legal descriptions (latitude-longitude or section-township-range) provided for ISF water rights listed in this Tabulation were generated by the ISF Decision Support System tool utilizing the decreed physical benchmarks.
