#### **RESOLUTION OPPOSING INITIATIVES 3 AND 45**

WHEREAS, water frequently does not naturally exist where and when it is needed in sufficient quantities to sustain human settlement and enterprise in Colorado; and

WHEREAS, as a scarce natural resource, water in Colorado requires a system of allocation and enforcement to meet the needs of Colorado's citizens and the natural environment; and

WHEREAS, Colorado's Constitution ratified the prior appropriation doctrine by stating: "The water of every natural stream, not heretofore appropriated, within the state of Colorado, is hereby declared to be the property of the public, and the same is dedicated to the use of the people of the state, subject to appropriation . . . "; and

WHEREAS, the prior appropriation doctrine was confirmed by the Colorado Supreme Court in Coffin v. Left Hand Ditch Co., 6 Colo. 443 (1882) and evolved to meet the public's needs through 150 years of court opinions and legislation; and

WHEREAS, Colorado's prior appropriation system has proven itself both successful and flexible in addressing the public's changing demands, beneficial uses, and values regarding Colorado water resources (for example, instream flow and recreational in-channel diversion water rights); and

WHEREAS, the Colorado Water Conservation Board was established in 1937 as a citizen board that now represents each major river basin in the state charged with the mission of conserving, developing, protecting and managing Colorado's water for present and future generations; and

WHEREAS, the Colorado Water Conservation Board supports Colorado's system of prior appropriation as a fair and orderly system for allocating Colorado's scarce water resources; and

WHEREAS, the Colorado Instream Flow and Natural Lake Level Program, established in 1973, is the oldest and most robust instream flow program in the nation, preserving the natural environment on over 9,000 miles of stream and over 475 lakes for present and future generations; and

WHEREAS, in addition to the Instream Flow Program, the Colorado Water Conservation Board administers and supports water-related programs that uphold public values including recreation, watershed health, reducing the impacts of flood and drought, protection of Colorado's water

entitlements, and working in a broad-based public process to meet the state's consumptive and nonconsumptive needs for water; and

WHEREAS, the Colorado Water Conservation Board, through the Interbasin Compact Committee and the nine basin roundtables, supports a statewide stakeholder process that actively engages citizens in public participation, education, and outreach to determine municipal, industrial, agricultural, environmental, and recreational water needs, along with projects and methods to meet those needs.

WHEREAS, two individuals drafted state constitutional initiatives rejecting Colorado's historical reliance on the prior appropriation doctrine for water allocation and replacing it with an undefined foundation of the public trust doctrine; and

WHEREAS, the adoption of either of these initiatives would result in takings of private and public water rights established under the prior appropriation doctrine that Coloradans rely on for beneficial uses for health and human safety as well as economic benefit; and

WHEREAS, the adoption of either of these initiatives would result in dramatic reallocation of public and private, human and financial resources from constructive development and allocation of Colorado's water resources to Colorado's courts and legal system.

**NOW THEREFORE BE IT RESOLVED** that the Colorado Water Conservation Board opposes both Initiative 3 and Initiative 45 as unwise, unnecessary, and disruptive to the fair and responsible allocation and stewardship of Colorado's scarce water resources.

**BE IT FURTHER RESOLVED** that the Colorado Water Conservation Board authorizes its Director to disseminate and make publicly available this resolution.
