Water Supply Planning /Watershed & Flood Protection-Spring Drought and

Flood Outlook

Staff Recommendation: This is an informational item only. No Board action is required.

Background:

The 2012 Water Year began October 2011 and runs through September 2012. So far, it has brought below average conditions to the State with both the eastern plains and the mountains receiving below normal precipitation and 70% of the state is currently designated in drought conditions ranging from D0 (abnormally dry) to D3 (drought- extreme). As a result of last year's dry conditions in the eastern plains, the Colorado Drought Mitigation and Response Plan remains in phase-two activation for the southeast and south central portions of the state. As of March 5th, the watersheds with the lowest percentage of average snowpack are the Colorado and Yampa/White with 80% each. The highest watershed is the South Platte with 90%, indicating that all river basins are below average for this time of year. However, following last year's record breaking snow season in the northern Colorado mountains, many reservoirs have carryover storage, but current low snowpack may present challenges should drier conditions persist.

Staff will present the latest information on both drought and flood conditions and outlooks for the coming weeks and months. Information on snowpack, reservoir levels, stream flows, potential response actions, and related topics will be presented. A review of last year's runoff season will be provided. Klaus Wolter of the University of Colorado will present his long-term forecast for the region and discuss possible impacts from the current La Nina event impacting Colorado's weather patterns.

A joint meeting of the Water Availability Task Force and the Flood Task Force will be held on March 22, 2012. For the latest monthly Drought Update, with detailed drought information, please see the March Director's Report. Also, daily flood threat bulletins will be available on the CWCB website during the Colorado flood season from May through September.
