**Finance – Loan Deauthorizations** 

City of Trinidad - North Lake Dam Rehabilitation Project

#### **Background**

The City of Trinidad loan request for the North Lake Dam Rehabilitation Project was originally approved at the March 2012 Board meeting. This project was to improve the spillway, improve the outlet works, and address seepage at North Lake Reservoir. The \$1.8M project was to be financed using 40% CWCB loan funds, 40% Water Supply Reserve Account grant funds, and 20% cash reserves from the City. Upon legal review of the City's charter, it was discovered that the City could not execute a loan contract with the CWCB unless revised its charter. Given the urgency of the project and the City's ability to cash fund up to 60% of the project, the City opted to move forward with construction in the fall of 2012 without a CWCB loan.


The City did obtain CWCB approval to draw grant funds without the matching CWCB loan component at the July 2012 meeting.
