Please find herein, Recharge Colorado's 75 percent progress report related to Water-Energy Nexus Workshop Series Grant (P.O. # OE PDA 1300000017) which was received from the Colorado Water Conservation Board (CWCB) in August of 2012. This progress report is submitted in accordance with the grant requirements. We have prepared this progress report in a format consistent with the CWCB's requirements for progress reporting.

Work Completed

From December 1, 2012 up to the actual workshops on December 10, 2012, the following tasks were completed as part of the water-energy nexus workshop series as defined in the scope of work contained in the approved grant:

Task 2: Plan and Promote Workshops

- Sent final workshop announcement for the Arkansas River basin on December 6, 2012 to boost attendance. Organizations that helped with outreach for this final announcement included:
 - Arkansas River Basin Roundtable
 - o City of Fountain
 - Fort Carson
 - Colorado Springs Utilities
- Prepared funding questionnaire for workshop.
- Prepared workshop survey.
- Created nametags for workshop attendees.
- Created sign in sheets for each workshop.
- Purchased necessary workshop materials (easel charts, voting dots, post it notes, markers, etc).
- Purchased breakfast, snack foods, and beverages for each of the events.
- Met with facilitators to train them on the workshop approach and the details of their facilitation efforts needed for the workshops.

- Contacted National Jewish Health to request audience response system donation for workshop events. Loaded system to computer, learned use of the software, and developed workshop materials to make use of the audience response system software.
- Communicated with panelists, facilitators, and attendees as necessary.
- Completed last minute efforts associated with logistics for workshop including responding to late requests for attendance, responding to attendee, panelist, and facilitator questions, final confirmations with caterers

There are no ongoing work activities associated with project completion. Remaining activities include conducting the workshops, post workshop outreach to the participants, and preparation of the final report.

Success of Meeting Goals and Objectives

The goals and objectives of the water-energy nexus workshop grant were met.

Obstacles Encountered

No significant obstacles were encountered between the 50 and 75 percent project complete stage. There were some late cancellations of attendees for the Colorado Springs workshop. As noted above, we worked through our workshop connections to send a final announcement for the workshop. The outreach effort was successful and the number of attendees at the Colorado Springs workshop was raised to a level that was appropriate for the workshop format and intent.
