

## **Statement of Work**

**WATER ACTIVITY NAME** – Agricultural Transfers Public Policy Working Group

**GRANT RECIPIENT** – Pikes Peak Regional Water Authority

**FUNDING SOURCE** – Arkansas and South Platte Basin Account \$20,000 (\$10,000 each basin)

### **OBJECTIVES**

The applicant is requesting a grant to help fund a facilitated dialogue with interested stakeholders regarding the need for legislation to facilitate alternative agricultural water transfers (e.g. agricultural fallowing) based on research into existing statutes. This proposal is partly in response to the proposed yet unsuccessful legislation (HB 1068) proposed last legislative session. The Arkansas basin roundtable is committed to furthering alternative water transfer methods and hopes to have an active fallowing program in their basin to help minimize their water supply gap. The goals of the working group are straight forward and are listed below:

- Review existing statutory law concerning agricultural transfers;
- Identify pertinent citations that might be modified for expediting agricultural transfers;
- Conduct a facilitated dialogue with the stakeholders; and
- Produce a summary report of the process.
