I am pleased to inform you that on July 17, 2013 the Colorado Water Conservation Board approved your loan request for the Well Replacement Project as described in the application and approved Loan Feasibility Study titled "Bellyache Ridge Metro District Well Replacement." The Board approved a loan not to exceed \$169,175 (\$167,500 for project costs and \$1,675 for the 1% Loan Service Fee). The loan terms shall be 30 years at the municipal high income rate of 3.0% per annum.

Finance - New Water Project Loans

Bellyache Ridge Metropolitan District - Well Replacement Project

#### Introduction

The Bellyache Ridge Metropolitan District (District) is requesting a loan for the Well Replacement Project (Project). From January through March of 2013, the District had to haul in water because declining well production was not able to keep up with demands. The total Project cost is estimated to be \$335,000. The District is requesting a loan from the CWCB for approximately 50% of the Project costs. The remaining project costs will come from a Department of Local Affairs (DOLA) grant. See attached Project Data Sheet for a location map and a project summary.

#### Staff Recommendation (Board Approved staff recommendation on July 17, 2013)

Staff recommends the Board approve a loan not to exceed \$169,175 (\$167,500 for project costs and \$1,675 for the 1% Loan Service Fee) to the Bellyache Ridge Metropolitan District for Well Replacement Project from the Construction Fund. The loan terms shall be 30 years at the municipal high income rate of 3.0% per annum. Security for the loan shall be in compliance with CWCB Financial Policy #5.

#### **Background**

The District is located in Eagle County approximately six miles west of Edwards, Colorado. The District's water system is supplied by three wells. The wells fill a 100,000 gallon storage tank and a 250,000 gallon storage tank.

The wells typically operate at a rate of 12.5 gpm to 25 gpm and operate 12 hours out of every 36 hours. Due to below average recharge during 2012, through the winter of 2012-2013 the wells pumped at rates of 1 to 2.5 gpm and operated 24 hours a day. During January through March of 2013, the water supply system was augmented with 240,000 gallons of hauled water.

Spring storms recharged the groundwater supply such that the District has not hauled water since March, but unless a new well is drilled hauling water will likely be required in the future.

#### Loan Feasibility Study

Thomas Zancanella, P.E. with Zancanella & Associates, Inc. in Glenwood Springs, Colorado prepared the Loan Feasibility Study titled "Bellyache Ridge Metro District Well Replacement," dated June 2013. The study was prepared in accordance with the CWCB guidelines.

#### Borrower - Bellyache Ridge Metropolitan District

The District was incorporated in 1981 as a Title 32 Special District. It services 65 lots with an average annual water use of 11.3 acre-feet. District revenues come from taxes and water user fees. It currently only collects 22.5 mills and has voter approval to collect up to 25 mills. In addition to a tiered rate structure for water service, it also collects \$25 per month as a drought surcharge fee.

#### **Project Description**

The purpose of this Project is to drill a 1,900 foot deep replacement well for Well #2 to provide for a long-term water source for the District. The new well will be located in approximately the same location as the existing well. It is expected to produce 25 gpm.
