Staff Recommendation:

Staff recommends approval of up to \$50,000 from the Metro Roundtable Basin Account to help complete the project titled: Rural Well Monitoring in Douglas County

Water Activity Summary: WSRA funding will provide the opportunity for the applicant to continue monitoring the county wide groundwater-level network established during an earlier phase (2011-2013) of this multi-year project. Approximately 8,021self-supplied private household or domestic wells in this rural portion of Douglas County pump groundwater from the Denver Basin aquifer, which is administratively known as nonrenewable. Therefore groundwater availability in this area may be insufficient for long-term demand. The existing county-wide groundwater-level monitoring network consists36 domestic wells throughout the county. Water levels are measured bi-monthly in all wells and 15 of these are equipped with pressure transducers for continuous (hourly) water-level monitoring. The creation of this network and the data collected from the study has added to the current network of wells currently being used to monitor water levels in the Denver Basin. Water levels measured from wells in this network over a long period of time provide a better assessment of current water resource and provide the basis from which to monitor long-term changes of the hydrologic system. This project will help document rural areas of the county that should be considered a priority in infrastructure planning efforts.

Discussion:

Staff endorses continuing efforts to monitor long-term groundwater levels in this hydrologic system.

Issues/Additional Needs:

No issues have been identified.

Staff Recommendation:

Staff recommends approval of up to \$50,000 from the Metro Roundtable Account to help complete the project titled: Rural Well Level Monitoring in Douglas County

This report may contain photographs, summaries of meetings and engineering reports/designs.

Engineering: All engineering work (as defined in the Engineers Practice Act (§12-25-102(10) C.R.S.)) performed under this grant shall be performed by or under the responsible charge of professional engineer licensed by the State of Colorado to practice Engineering.

3. Provide a brief description of your organization

The Rural Water Authority of Douglas County (The Authority) was established on October 8, 2008 by the Board of Douglas County Commissioners, entering into an Intergovernmental Agreement (IGA) with the Grandview Estates Rural Water Conservation District pursuant to the provisions of Article XIV, Section 18(2)(a) of the Colorado Constitution, and C.R.S. § 29-1-204. Since that time, the Thunderbird Water and Sanitation District and Louviers Water and Sanitation District have also signed the IGA as Participants.

The Authority consists of a nine member Board of Directors:

- a. 5 Director Districts represent individual water providers (an owner of a water well permitted or operated for domestic or household purpose or services),
- b. 3 Small Water System Directors (operate a small water system for 500 equivalent residential units or less)
- c. 1 Douglas County Commissioner

The purpose of The Authority is to assist its participants in developing water resources, systems, in whole or in part, for the benefit of Rural Water users and owners of land within its service area. The Authority's defined functions and services include (a) collaborating and cooperating with other local, regional, and statewide water supply agencies in the development of water supply plans and conservation of water resources, and (b) educating and informing water users as to issues affecting an adequate, sustainable, and reliable water supply.

The Authority represents the owners of approximately 8,000 household and domestic wells and 15 small water system providers in the unincorporated area of Douglas County. The estimated population within the Authority's service area is 28,620 (2010), about 9.8% of Douglas County's population, and the service area comprises 80.49% of Douglas County's geographical area.

A representation of the Authority's Service Area, Small Water Providers and Director Districts can be found in Attachment B of this Application.

The Applicant will be the contracting entity for the grant, but has an ongoing subcontract with the **United States Geological Survey** (**USGS**), a scientific agency of the United States government, in pursuit of the ongoing Work Plan. A bureau of the United States Department of the Interior, the USGS is that department's sole scientific agency, and hydrology is one of their specialties.

5. Please provide an overview/summary of the proposed water activity (no more than one page). In 1990, the population of Douglas County, Colorado was just over 60,000 people. Between 2000 and 2008 the population had increased by about 60 percent from 175,766 to 280,621 residents occupying more than 101,000 housing units. The Douglas County planning commission forecasts the population to grow to more than 450,000 by 2030. While some Douglas County municipal water providers have water rights to the South Platte River and its tributaries Cherry Creek and Plum Creek, their allocations do not provide enough water to satisfy the renewable supplies necessary to fulfill the existing water demands of the county. Development of the groundwater resources has become necessary to meet the growing needs of the county.

About 485 mi² of central and eastern Douglas County are underlain by the Denver Basin aquifer system, and groundwater pumped from the aquifers is the primary source of municipal and domestic water supply in Douglas County. Domestic groundwater use is less than municipal use but is widespread throughout the basin, and rural areas depend solely on self-supplied groundwater for water supply (Paschke, 2010). Douglas County reports the total number of domestic private wells increased from 1,242 in 1970, to 8,264 by 2008, 8,021 of which are individual household or domestic wells. The Denver Basin aquifer system is administratively recognized as nonrenewable by State water law because the aquifers are primarily confined and receive little precipitation recharge (Graham and VanSlyke, 2004). Therefore groundwater availability in this area may be insufficient for long-term demand.

To assess seasonal and long-term water-level changes, a county-wide groundwater-level monitoring network was established for Douglas County in June, 2011. The network consists of 36 domestic wells throughout the county (Attachment C-Figure 1). Water levels are measured bi-monthly in all wells and 15 of these are equipped with pressure transducers for continuous (hourly) water-level monitoring (Attachment C-Figure 1). The creation of this network and the data collected from the study has added to the current network of wells currently being used to monitor water levels in the Denver Basin.

The primary objective of this grant's work is to continue monitoring the county wide groundwater-level network, established during the 2011-2013 phase of the project. Water levels measured from wells in the network over a long term provide a better assessment of the current water resource and provide the basis from which to monitor long-term changes of the hydrologic system. This project will help document rural areas of the county that should be considered a priority in infrastructure planning efforts. In order to develop data that can be used reliably to evaluate groundwater supply trends, it is necessary to have as long a time series as possible. Funding this grant would continue to

meet that need. <u>Note</u> that continued funding of this project will result in less cost per well tested than in the initial phase, due to the recently-approved grant by the CWCB Board of \$19,960 from the Severance Tax Trust Fund to purchase pressure transducers for the project.

Part III. - Threshold and Evaluation Criteria

¹ 37-75-102. Water rights - protections. (1) It is the policy of the General Assembly that the current system of allocating water within Colorado shall not be superseded, abrogated, or otherwise impaired by this article. Nothing in this article shall be interpreted to repeal or in any manner amend the existing water rights adjudication system. The General Assembly affirms the state constitution's recognition of water rights as a private usufructuary property right, and this article is not intended to restrict the ability of the holder of a water right to use or to dispose of that water right in any manner permitted under Colorado law. (2) The General Assembly affirms the protections for contractual and property rights recognized by the contract and takings protections under the state constitution and related statutes. This article shall not be implemented in any way that would diminish, impair, or cause injury to any property or contractual right created by intergovernmental agreements, contracts, stipulations among parties to water cases, terms and conditions in water decrees, or any other similar document related to the allocation or use of water. This article shall not be construed to supersede, abrogate, or cause injury to vested water rights or decreed conditional water rights. The General Assembly affirms that this article does not impair, limit, or otherwise affect the rights of persons or entities to enter into agreements, contracts, or memoranda of understanding with other persons or entities relating to the appropriation, movement, or use of water under other provisions of law.

A Brief Update on the Findings of the Current Grant and justifictaion for this grant continuing the work:

Current Findings

Water levels have been measured bimonthly from June 2011 through April 2013. Analysis of the water level measurements shows seasonal fluctuations as expected. Water levels rise in the winter months (October through March) and decline during the summer (April through September). The time-series data indicate, on average, the highest water levels are observed during early March and the lowest are observed in late August. The median difference between the highest and lowest observed water levels for all wells in the Upper Dawson is 3.6 feet, over 9 feet in the Lower Dawson, and about 10.5 feet in the Denver. The minimum difference between the highest and lowest observed water levels in a given well ranged from about 0.9 ft. in the Denver to about 1.4 Lower Dawson. The maximum difference between the highest and lowest observed water levels in a given well ranged from over 9 ft. in the Arapahoe to over 80 ft. in the Laramie-Fox Hills.

Analysis of the water level measurements shows a year-to-year decline in all of the aquifers (Attachment C-Figure 2). A comparison year to year water level measurements (June 2011 to June 2012, August 2011 to August 2012, October 2011 to October 2012, December 2011 to December 2012, February 2012 to February 2013, and April 2012 to April 2013) shows an average decline in water levels of 0.6 ft. in the Upper Dawson, 2.9 ft. in the Lower Dawson, 3.6 ft. in the Denver, 1.5 in the Arapahoe, and 13.0 ft. in the Laramie-Fox Hills.

Analysis of the time-series data shows a detailed and more complex record of water level changes. Of note was the observed rise in water level over 5 ft. in less than a 2 week period in early July 2012 during the seasonal decline. This marked rise in the water level occurred in a Lower Dawson well (Attachment C- Figure 2a) on the northern edge of the county and was observed, to a lesser extent, in wells on southern edges of the county and in several Denver wells (Attachment C- Figure 2b).

Continued Monitoring

Funding for the current monitoring activities will be exhausted in June 2013 after two full years of data collection. Continued water level monitoring will be necessary to determine if the declines observed to date are in response to short term events or are part of a longer cycle. If water level declines continue, additional data can be used to better quantify the rate of decline. This information can be used by State and local officials when making critical decisions about the management of local water resources. Data collected from the study can also be used to calibrate current or future groundwater models that can aid in the better understanding of the hydrologic conditions.

The ultimate goal of the project is to have at least five years' of sampling data to indicate in a time series where changes in aquifer water levels are taking place. After two years of data collection, this application would fund one more year of the labor portion of the project. The cost of leasing pressure transducers would be obviated by a separate grant from the Severance Tax Trust Fund, which was awarded March 9, 2013 (see Attachment C).

INTRODUCTION AND BACKGROUND

This project established a county-wide groundwater-level monitoring network in 2011 for the long-term monitoring of the water resources of rural areas of unincorporated Douglas County, Colorado. A scientific evaluation of groundwater resources in the Authority's service area has never been accomplished. In 2010, Douglas County estimated the population would grow from 293,521 residents to more than 444,784 by 2030. Some water providers in the county have surface-water rights, but their allocations do not provide enough water to satisfy the renewable supplies necessary to fulfill the existing water demands of the county. Development of the groundwater resources will continue to be necessary to meet the growing needs of the county.

Funding of this application would continue aquifer water level sampling for one more year. The ultimate goal of the project is to collect at least five years' data, for a more accurate representation of changes in the groundwater levels.

OBJECTIVES

The primary objective of this study is to continue monitoring the county wide groundwater-level monitoring network for one year (12 months), to eventually achieve long-term monitoring of the water resources of Douglas County, Colorado. The network consists of 36 wells throughout the county. Water levels will be measured bi-monthly in all wells; ten sites are equipped with pressure transducers for continuous monitoring, and 26 wells will be monitored manually. Water levels measured from wells in the network will provide an assessment of the current water resource and provide the basis from which to monitor long-term changes of the hydrologic system.

TASKS

TASK 1 - Monthly Water- Level Measurements and data Management

<u>Description of Task</u> Water levels in 36 wells (*Attachment C-Figure 1*) will be measured on a bimonthly basis and recorded. This task includes reviewing the field data forms for accuracy, and entering the water level data into the NWIS database. Fifteen wells are equipped with a pressure

transducer and data recorders for recording hourly water level measurements.

Method/Procedure

Completion of this task is estimated to require 48 hours every other month to measuring water levels and perform data management and quality assurance procedures. After each round of water-level measurements, hydrographs will be produced and reviewed to ensure that the selected wells are providing reliable data. This task is estimated to require a total of 336 hours over the 12 month monitoring.

Data log of water levels in selected wells. Data will also be published on the USGS National Water Information System Web site (NWISWeb).




CWCB is entitled to an amount up to a 5% share of the Operational Account of the Severance Tax Trust Fund. In January 2013, CWCB received internal requests and outside applications for funding that becomes available from the Operational Account in July 2013 via the Long Bill enacted by the General Assembly. CWCB Staff reviews the applications and then recommends to the Board the projects that should receive funding. We expect to receive \$1,275,500 in funding; however, should that amount be changed, the project funding will also need to be revised. Table 1 on page 2 provides a summary of the recommended and non-recommended projects by CWCB Staff. These projects are described in more detail following Table 1(see each write-up by the corresponding Project Number).

Recommendation

Staff recommends that the Board approve the proposed funding for each of the projects from the Operational Account of the Severance Tax Trust Fund as summarized as Table 1 to this memo. Recommended projects are numbered 1 – 26 and projects not recommended are numbered 27 – 34. Board approved staff recommendations, with project funding decreases/increases presented during Board presentation, and the addition of Project No. 31.
