Summary

This application (attached) seeks a finding of reasonable diligence for a Recreational In-Channel Diversion (RICD) on the Blue River to be located in Silverthorne, CO originally decreed in Case No. 5-04CW217.

Silverthorne's white water course is to be located on the Blue River between the Highway 70 bridge and the Highway 9 bridge in Silverthorne, Colorado. The reach of the proposed white water course is shown on the map attached and includes 3 decreed control structures. The RICD is decreed for the following flows:

Basis for Statement of Opposition

The CWCB would like to ensure that the Applicant has provided proper evidence to support its claim for a finding of reasonable diligence for the RICD water right. Improper diligence or perfection of this RICD may affect Colorado's ability to promote maximum utilization of the waters of the State.

F. <u>Use</u>: The flows are claimed between the hours of 7:00 a.m. and 8:00 p.m. for both Level One and Level Two Flows. Level Two Flows are claimed for up to four days per weekend, depending on the national holiday. Specifically, the water right for the Memorial Day and Labor

Day Level Two Flows will be in effect only on Friday, Saturday, Sunday, and Monday. The water right for the Fourth of July Level Two Flows will be in effect as follows: 1) if the Fourth of July is on a Thursday, the water right will be in effect on Thursday, Friday, Saturday and Sunday; 2) if the Fourth of July is on a Friday, Saturday, Sunday or Monday, then the water right will be in effect on Friday, Saturday, Sunday and Monday; 3) if the Fourth of July is on a Tuesday, then the water right will be in effect on Saturday, Sunday, Monday and Tuesday; and, 4) if the Fourth of July is on a Wednesday, then the water right will be in effect only on Wednesday. The amounts decreed herein are for recreational in-channel diversion within each of the Course structures. The court finds that the amounts claimed are the minimum amounts necessary to provide a reasonable recreational experience during each of the above time periods.

4. Provide a detailed outline of what has been done toward completion or for completion of the appropriation and application of water to a beneficial use as conditional decreed, including expenditures:

During the diligence period, among other actions, Applicant acquired lands to provide needed river and continuous shoreline access within the RICD, completed improvements to Salt Lick Gulch to move a mid-RICD culvert and discharge to above the start of the RICD, requested and received a Conditional Letter of Map Revision from the Federal Emergency Management Agency, with other parties Applicant completed the construction of Old Dillon Reservoir that can release water for this RICD, Applicant requested and received a review of the hydrologic characteristics of the planned RICD to determine if any modifications need to be made based on knowledge and experience gained on RICD construction during the diligence period, requested and received an engineering summary letter and updated estimate of probable cost from a whitewater design engineer and Applicant's Capital Fund has a preliminary budget of \$500,000 for construction of the RICD to begin in 2016. Finally, Applicant is a beneficiary of the completed Colorado River Cooperative Agreement and will receive funds that can also be used for construction of the RICD. Applicant's total expenditures during the diligence period were in excess of \$50,000.00 including actual payments and in-kind staff time, but not including the costs of the land acquisition and value of the land.

Names(s) and address(es) of owner(s) or reputed owners of the land upon which any new diversion or storage structure, or modification to any existing diversion or storage structure is or will be constructed or upon which water is or will be stored, including any modification to the existing storage pool: Applicant owns or controls the land or right-of-way on which all structures described in this application are located.
- 6. **Request for finding of reasonable diligence:** Applicant hereby requests the Court to enter a finding that Applicant is proceeding in a reasonably diligent manner and that the waters claimed by Applicant can and will be diverted, or otherwise captured, possessed and controlled and will be beneficially used and the project can and will be completed with diligence and within a reasonable time.




