East and West Slope representatives are openly discussing the development of New Supply and an additional transmountain diversion. Alan reported that there was enough progress that a special meeting was scheduled for March 25th in order to continue the discussion of the development of New Supply from the Colorado River.

# **CWCB Report**

The CWCB meets next week in Denver. They'll be spending a half day talking about the Colorado Water Plan. On Tuesday there will be a chance for public input on the Colorado Water Plan. They'll also be considering in-stream flow recommendations, some of which are in our basin.
