Ladies & Gentlemen:

Pursuant to that certain Loan Contract, Contract No. C150378 dated November 25, 2013 in the amount of \$1,636,200.00, by and between the State of Colorado for the use and benefit of the Department of Natural Resources, Colorado Water Conservation Board ("State") and The North Poudre Irrigation Company as the Borrower ("NPIC"), we hereby provide to the State our opinion as follows:

- (1) NPIC is a Colorado non-profit corporation in good standing:
- (2) The above referenced Loan Contract and Appendix documents have been duly executed on behalf of NPIC by Nels Nelson as President and Sharon Seaworth as Office Manager and Corporate Secretary;
- (3) That the said President, Nels Nelson and Corporate Secretary, Sharon Seaworth were duly elected at a properly called and held Meeting of the Shareholders and Board of Directors of NPIC and they do have the authority to execute the Loan Contract and to bind NPIC;
- (4) Attached to the Loan Contract as Appendix 3a and 3b are original Resolutions of the Board of Directors and Shareholders of NPIC which said Resolutions approve the Loan Contract and attached Appendix documents including the authorization for the corporate officers to sign said Loan Contract and other necessary
