Re: 50% Progress Report on the Town of Erie's Water Conservation Plan Development Dear Ben,

The Town of Erie (Erie) has completed 50% of the level of effort necessary to update its Water Conservation Plan (Plan). Per requirements of CWCB's *Grant Guidelines for Water Conservation Planning Projects* this letter addresses the following: success of meeting previously identified goals and objectives; encountered obstacles; preliminary findings and accomplishments; and revisions to the schedule.

The main objective of this planning effort is to develop an effective water conservation plan that integrates the knowledge of Erie staff with the values of the community while remaining on schedule. We have held a kick-off meeting and one workshop with Erie staff to obtain the majority of information needed to develop a preliminary draft for Erie staff review. A second workshop as included in our original application is not necessary, although additional correspondence will be needed with Erie staff to ensure that sufficient information is provided to AMEC to complete the Plan.

We have currently not encountered any specific obstacles with the Plan development. One particular challenge we identified during this planning effort is being able to quantify the water conservation savings attributed to individual conservation activities. We plan to address this particular challenge by providing high level estimates of savings by conservation activity

category (e.g., foundational, ordinances and regulations, etc.) and focusing more on demand reduction trends. We have found that Erie has successfully met the majority of water conservation goals defined in the 2008 Water Conservation Plan.

We anticipate completing an initial draft of the Water Conservation Plan by the end of June and initiating the 30-day public review process by mid/end of July. Please see the attached updated schedule.
