Background

The following tables outline the Board's instream flow appropriations from January 2014 and January 2015 contested by the identified parties. During the new appropriation process, staff held multiple meetings on these appropriations with stakeholders in an attempt to identify and address concerns. In addition, staff has contacted, or is in the process of contacting the contested parties and their attorneys to further define their issues and explore whether any mutually acceptable terms and conditions can be reached on each stream in order to alleviate the need for a hearing.

Staff recommendation

Staff recommends that the Board designate a Hearing Officer for each contested instream flow appropriation. Staff further recommends that the Board set the hearing date for all appropriations, except the two segments of Yellow Creek, to be held in conjunction with the Board's September 2015 meeting, which will be held in Montrose Colorado. For the Yellow Creek appropriation, staff recommends that the Board set the hearing date to be held in conjunction with the Board's November 18-19, 2015 meeting (location to be determined).
