DELTA CONSERVATION DISTRICT INVASIVE PHREATOPHYTE CONTROL PROGRAM GRANT PURCHASE ORDER # OEPDA14000000049

Since getting the IPCP grant contract in the spring of 2013 the Delta Conservation District has treated and retreated 60 parcels of land, according to Delta County's tax map, along the North Fork of the Gunnison River. All initially treated parcels under the ICPC grant were retreated at least once and some parcels initially treated under other invasive removal grants were retreated two additional times. Initially treated parcels under the ICPC grant were all retreated a second time. Most parcels were privately owned, but also included state highway department land, Delta County Public School land, Town of Paonia land, North Fork Park and Recreation land, Paonia River Park land owned by the NFRIA-WSERC Conservation Center, now the Western Slope Conservation Center and lands in conservation easement. Silverleaf buffaloberry starts were planted on two parcels to promote native species diversity.

Treatments of the parcels involved mechanical removal of Russian olive, tamarisk and occasional Siberian elm utilizing chain saws. Following chain saw removal, stump cuts were treated with herbicide, normally Garlon Ultra 4 with methylated seed oil and blue marker dye. In warmer weather above 85 degrees Polaris was used as the herbicide in place of the Garlon. Areas of retreatment utilized Garlon Ultra 4 with Milestone and Bios 90. In areas where large Russian olive trees would have fallen into the river, girdling of the trunks was utilized to kill the trees. Slash was collected and put in habitat piles. Work crews were utilized from the Western Colorado Conservation Corps (WCCC). When the WCCC had staffing problems and could not provide any crews for 6 weeks of promised work in the fall of 2014, four former crew leaders total from the Southwest Conservation Corps and the WCCC were utilized to progress the work before the end of March 2015.

Two public education outreach sessions educating members of the public were conducted in addition to a newspaper article and an internet article. The first was in Orchard City on January 20, 2015 with 38 attendees and the second on February 3, 2015 in Delta with 42 attendees. Presenters covered the steps of Integrated Pest Management to control List A and B invasive weeds. Dr. Thomas Grant, professor in the Master of Environmental Management program at Western State University, John Rizza, Regional Specialist in Small Acreage Management at Colorado State University, and Shannon Hatch, Restoration Coordinator with the Tamarisk Coalition, presented in Orchard City with some emphasis on Russian olive control because of the heavy infestation in the Surface Creek drainage. Melissa Werkmeister, the former Mesa County Weed Coordinator and current Bureau of Reclamation Resource Use Technician, gave a comprehensive session on Invasive Weed identification and control in the city of Delta, assisted by John Rizza and Shannon Hatch. The Tamarisk Coalition identified excellent educational materials which were reproduced in bulk by the Delta Conservation District and distributed at both workshops.

Because of the heavy native revegetation by narrow leaf cottonwood trees and willows along the North Fork of the Gunnison River, no focused revegetation program to date has been found to be

necessary. In two areas, however, small native silverleaf buffaloberry trees were planted. It is anticipated that selective additional plantings of these native trees will be continue to be done as the trees become available. Several healthy stands of buffaloberry have been identified along the river, which provide excellent bird habitat. Work crews have all been instructed on the difference between invasive Russian olive and native silverleaf buffaloberry to avoid inadvertent removal of this valuable native species.

The below is the list of land parcels by tax record owner where initial and subsequent retreatment of Russian olive and tamarisk removal have taken place. Some few parcels may have changed owners since the parcel list was current as of 2013. Several owners possess multiple parcels with the number of parcels indicated parenthetically. They are described from the north in the direction of the Paonia Reservoir Dam to the south with alternating East (E) and West (W) designations reflecting their location on the bank sides of the North Fork of the Gunnison River.
