- Thabault called the meeting to order at 10:02 a.m. Central time and the group proceeded with a roll call. 49

Draft PRRIP FY2013 Budget 52

Kenny provided an overview of the current drafts of the FY2013 budget and associated work plan, 53 54 including Exhibits A and B of the Executive Director contract for 2013. Czaplewski said 2013 will be a precedent year in land because we will be selling or auctioning off surplus land, so how do we handle 55 income in this budget? Kenny said that income is not reflected in the budget. From a cash flow 56 perspective, that money will go through the NCF and then back to the participants. One option the 57 income provides is when looking for funds for J-2, that money might be a windfall. Campbell asked 58 about WP-4(c). Kenny said that is Net Controllable Conserved Water and the Program will either take or 59 reject that water in 2013. Kraus said offering that water is part of CNPPID's FERC license requirements. 60 Kenny said he picked the \$250 price but this water is institutionally easy because up to 6,000 acre-feet of 61 water is available every year and would be taken in Lake McConaughy. All of that might justify paying a 62 premium. Barels asked if the \$250 per acre-foot is for just next year or for the remaining years of the 63 First Increment. Kenny said that is a lease price that would hold for the rest of the First Increment. 64

LaBonde asked about the Program's share of the initial payment for the J-2 project. Kenny said the 66 Program initial payment we be about \$13 million. The rest would come from CNPPID and the State of 67 Nebraska. Taddicken asked about WC-6 and if it is the Program's purview to do a study that extends 68 beyond the Associated Habitats. Kenny said there was a lot of discussion about this at the TAC and the 69 thought was the information that would be obtained beyond the Platte River would ultimately be valuable 70 for assessing our work on the Platte. Urie asked about the billing rates included in Exhibit A of the ED 71 contract for 2013. It looks like what is in the budget spreadsheet is based on a lower billing rate, but the 72 GC is being asked to approve higher billing rates. Kenny said the billing rates listed at the top of Exhibit 73 A are average rates per category. The rates at the bottom are the maximum billing rate. So, the budget 74 estimate is based on those average rates listed at the top and the number in the budget spreadsheet is 75 accurate in terms of being based on those average rates. Barels thanked Kenny and the staff for all the 76 work put into the spreadsheet and work plan, as well as the associated explanations. The EDO has 77 78 learned from previous questions and the lack of questions today reflects the good job done by the EDO. Kenny thanked Barels for the kind words. 79
