BIP Coordinator – Gary Barber (see report)

Gary will give a brief overview of the BIP for new folks at the roundtable meeting. WSRA Severance Tax funds are likely to be down by 90% next year, so focus is on alternative and multiple sources of funding.

Gary reviewed his Projects List, status of projects, new projects and activities in the last month, as well as planned activities. He presented possible new projects and concepts that might be a good use of his time, and asked for feedback.

Gary also discussed the grant application to be presented today: Pueblo Channel Debris Removal and Habitat Restoration Project. The applicant is the Lower Arkansas Water Activity Enterprise, and project partners include Pueblo County, Fountain Creek Watershed, Flood Control and Greenway District, and LAVWCD. Project partners will provide the bulk of funding. Total project cost = \$255,000.
