2016-2019 North Platte Basin Roundtable Education Action Plan

Background Information:

Since 2010, the North Platte Basin Roundtable has worked with the Public Education, Participation and Outreach Workgroup (PEPO) and the Colorado Foundation for Water Education (CFWE) to strengthen their education and outreach activities. As the result, the North Platte Basin Roundtable developed a functioning Education & Outreach Committee tasked with creating an Education Action Plan (EAP), the first version of which was approved in January of 2011. The EAP details the educational goals and tasks most effective for the basin roundtable. It identifies roundtable member education activities that promote a well-informed and high-functioning basin roundtable. It also defines public participation objectives and appropriate implementation methods.

During the 2016-2019 time frame, the PEPO Workgroup of the IBCC and the Basin Roundtable Education Liaisons will be working with their basins to implement EAPs that reach out to decision makers and stakeholders of their Basin Implementation Plan (BIP). It will let the decision makers in the basin understand how they are represented, the status of the basin's consumptive and non-consumptive needs, planned projects, current river operation and opportunities and constraints associated with different hydrologic cycles. Where appropriate, this effort can also help the roundtable outreach to potential project proponents for the new projects and methods needed to meet future water needs to determine if they are interested in being partners or the lead entity. The North Platte Basin Implementation Plan indicates the components and activities of the EAP will continue to be utilized to facilitate public outreach and education related to the North Platte Basin.
