CONSENT AGENDA: Item 4 - New Prequalification Projects

The Finance Section compiles a list of prequalified projects for the Water Project Loan Program. In order to be included on this list, potential borrowers must submit a Loan Application and three years of financial statements to the CWCB staff. In addition, Borrowers must have a defined project, performed preliminary engineering, and have a reasonable estimate of the project costs before being placed on the Prequalification Project List.

Projects on this list fit the initial criteria of the Water Project Loan Program; however, the list does not constitute loan approval. In order to receive a loan, borrowers must additionally submit a completed Loan Feasibility Study for review by CWCB staff. Staff will then prepare a recommendation to the Board for approval at a future CWCB meeting. Projects will remain on this list for one year from the date of the application or until Board approval of a loan.

The Upper Platte & Beaver Canal Company (Company), located in Morgan County, provides irrigation water to a 9,600-acre service area just west of the City of Fort Morgan to approximately 4 miles east of the Town of Brush. The Company seeks to repair or replace the existing river-spanning diversion structure on the South

Platte River, which connects to the diversion structure for the Deuel & Snyder Improvement Company. The combined average annual delivery volume for the two companies is 16,600 acre-feet.

The two companies originally had separate diversion structures on each side of the river, separated by an in-stream island. In 1965, flooding removed this separating island, necessitating construction of a diagonal dam structure connecting the two diversion structures, thereby replacing the function previously served by the in-stream island. Recent investigations of the overall structure have found problem areas where the underlying bedrock has been undermined, resulting in structural damage that must be addressed so that the diversion structure does not catastrophically fail in the future.
