Rio Grande Basin Roundtable Education Action Plan (2015-2018)

Background Information:

Article VII of the Interbasin Compact Committee (IBCC) by-laws address the formation of workgroups to assist it in its deliberations and functions. The Public Education, Participation, and Outreach (PEPO) workgroup is charged with creating a process to inform, involve, and educate the public on the IBCC's activities and progress of the interbasin compact negotiations, and create a mechanism by which public input and feedback can be relayed to the IBCC and compact negotiators. It is the only workgroup written into the legislation (C.R.S. 37-75-106).

In 2014-2015, the PEPO Workgroup will assist the basin roundtables in strengthening their education and outreach activities. The EAP will detail the educational goals and tasks most effective for the basin roundtable. It will identify roundtable member education activities that promote a well-informed and high-functioning basin roundtable. It will also define public participation objectives and appropriate implementation methods.

In 2015-2018, the Rio Grande Basin Roundtable will strengthen its Education & Outreach efforts through the creation of their Education Action Plan (EAP). To assist the basin roundtables in implementing their completed EAPs, the Colorado Water Conservation Board (CWCB) has created an education fund. All basin roundtables with a completed EAP will have the opportunity to receive up to \$6,500.00 in state funds per year for action plan implementation.

Executive Committee Members. All roundtable members are encouraged to provide input and suggestions to the Executive Committee. The Executive Committee seeks to represent fully the agricultural, municipal, industrial, recreation and environmental interests of the basin. Assessment.

Topic 1 and 2: An assessment of the remaining public events will be conducted briefly following the event to determine if: a) attendees left the event with a greater understanding of the Roundtable's purpose and water activities, and; b) attendees felt the event was worth their time. (*This assessment will be conducted using a written survey*) C.) participants will be motivated to participate in Round table meetings and Events.

TOPIC 2: the Rio Grande Basin PEPO Liaison (Judy Lopez) will conduct a follow-up survey (6-7 months following the event) to determine if and how attendees have made use of the information provided during the event. Since the participants will also be regularly available at Roundtable meetings, the follow-up survey will be conducted at the convenience of members who are present at Roundtable meetings.

Sustainability Framework. It is recommended that the PEPO Liaison, Education Subcommittee and Executive Committee develop a strategy that ensures to a reasonable degree that educational activities are beneficial and useful to participants and get adjusted to meet participant needs in the 2016-2017 and 2017 and 2018 fiscal years.
