

Dear Colorado Water Conservation Board Members,

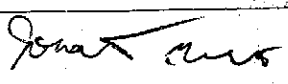
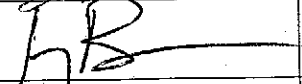
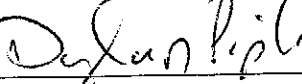
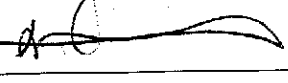
