PRRIP Habitat Management

Farnsworth discussed habitat management activities planned under the bid packages for the Pawnee and Ft. Kearney habitat complexes. He also discussed the fall disking RFQ. Fassett asked whether the Program gets a number of bidders on this type of work. Farnsworth predicted we would get between 3-6 bidders. We generally always get 2-3 bidders and then additional bids come in based on how busy they are with other work. Fassett asked if the Program has developed a list of trusted contractors that do good work. Farnsworth said yes, we have built those relationships over time. LaBonde asked if a caddisfly survey had been completed at the Ft. Kearny Complex. Farnsworth said there are no sloughs present so it is not an issue.

Farnsworth discussed the need for permitting related to broad scale recharge and the related contract amendment with HDR for Section 404 permitting activities at the Cottonwood Ranch Complex. Fassett asked if this amendment is written generically for sites as they may be determined or if this is specific to the Cottonwood Ranch Complex. Farnsworth said the scope is generic and is written to get wetland delineations done before talking with the Corps. The EDO will work with HDR during the winter to get site-specific impacts assessed in order to write the permit application next spring.

Farnsworth discussed the contract modification related to modeling removal of the sand dam at Jeffrey Island. This pertains to sediment augmentation and south channel degradation and investigating the question of how to limit the amount of sediment and effort required to offset the sediment deficit. One option would be to make the sand dam ephemeral so that it washes out during high flow events and would allow sand and water access to the south channel during those events. The EDO is taking this very slowly and modeling would be done to predict what would happen if the sand dam washes out during high flow events and then replace it. The modeling exercise will help us think through the viability of this option. Tetra Tech developed modeling tools for the Program and has been contracted to utilize these tools before like at the North Platte choke point.

Sellers moved to approve the Sand Dam Removal Modeling contract modification; Beardsley seconded. Kraus abstained. Contract modification approved.
