#### 29 Welcome & Administrative

Beardsley called the meeting to order at 10:03 AM Central Time. LaBonde had a conflict and could not participate in the meeting. Kenny said after approving the minutes he would like to discuss something generated from the EDO in a couple weeks.

Farnsworth said the EDO would be proposing to adjust its strategy for acquiring contract services for weed spraying in 2017.
