Fund Advisory Committee Leaders:

Enclosed are the financial reports for your fund for the month of June 2012. These include a fund report and an audit trail for the month of June 2012. Also enclosed is the Endowment Investment Summary, which details the current and historic returns for investments in our three long-term investment models. These reports are being sent <u>only</u> to the individual designated as the key contact for your affiliated fund with the understanding that you will distribute these reports to others on your Fund Advisory Committee and those individuals involved with particular projects and accounts so they can see the results of your collective efforts.

The Nebraska Community Foundation has an annual audit of our financial statements by an independent accounting firm. Our audit for the year ended June 30, 2012 will begin at the end of July. Once the audit is complete, we will send you the full-year financial statements for your affiliated fund.

We are pleased to let you know that NCF has received reconfirmation of our compliance with National Standards for Community Foundations. National Standards is a program of the Council on Foundations that recognizes community foundations who have achieved high standards for operational quality, integrity and accountability. More information about National Standards can be found on the NCF website.

Your fund report includes updated information at the bottom of the page in the section entitled "Permanent Endowment Information." For each of the endowed accounts within your affiliated fund, we are providing the amount that may be granted for fiscal year 2013 ("FY 2013") in accordance with the Nebraska Community Foundation Investment Policy. This should help you plan your grantmaking for the fiscal year that began on July 1.

The first line in this section shows the 12-quarter average asset balance for the account, which is the basis for computing your endowment payout; the second line shows the payout percentage, which is based on the asset allocation model you have selected for the account. These numbers are multiplied to arrive at the FY 2013 payout available. The next line shows any unused payout from FY 2012 which is also available for granting during fiscal year 2013.

This information will be the same on your fund report each quarter of the current fiscal year. Because the endowment payout is calculated using asset balances from prior years, the number will not change throughout the year. We will not reduce the amount shown on subsequent reports by the amount you grant during the year, so you will need to track your grantmaking and subtract your grants from this amount throughout the year.
