**Notice of Complaint

Take notice that on [date], 2016, pursuant to Sections 206 and 306 of the Federal Power Act ("FPA"), 16 U.S.C. §§ 824e, 825e, and Rule 206 of the Rules of Practice and Procedure of the Federal Energy Regulatory Commission ("FERC", or, the "Commission"), 18 C.F.R. § 385.206, Jeffrey Lake Development, Incorporated, a Nebraska non-profit corporation, ("Jeffrey" or "JLDI") has filed a Complaint against the Central Nebraska Public Power & Irrigation District ("Central") alleging that Central has violated one or more provisions of its license to operate the Kingsley Dam Project Number P 1417. Jeffrey, pursuant to 18 C.F.R. § 385.206(h), seeks **FAST TRACK PROCESSING**, and is asking the Commission to issue an Order, i) directing Central to stop its interference with Jeffrey's residential and recreational use and enjoyment of Jeffrey Lake, and, (ii) directing Central to stop violating its own land and shoreline management plan by requiring Central to both participate in, and allow adequate measures to prevent what has become continuing and significant erosion to the

shorelines surrounding Jeffrey Lake, and, in particular, and to reasonably regulate the water level maintained in Jeffrey Lake, so as to not encourage erosion.

Any person desiring to intervene or to protest this filing must file in accordance with Rules 211 and 214 of the Commission's Rule of Practice and Procedure (18 C.F.R. § 385.211 and 385.214). Protests will be considered by the Commission in determining the appropriate action to be taken, but will not serve to make protestants parties to the proceeding. Any person wishing to become a party must file a notice of intervention or motion to intervene, as appropriate. The Respondent's answer and all interventions, or protests must be filed on or before the comment date. The Respondent's answer, motions to intervene, and protests must be served on the Complainant.

The Commission encourages electronic submission of protests and interventions in lieu of paper using the "eFiling" link at <http://www.ferc.gov>. Persons unable to file electronically should submit an original and 14 copies of the protest or intervention to the Federal Energy Regulatory Commission, 888 First Street, N.W., Washington, D.C. 20426.
