# 2007-2012 LTPP & WC HABITAT AVAILABILITY ASSESSMENT AGREEMENT between

# PLATTE RIVER RECOVERY IMPLEMENTATION PROGRAM, NEBRASKA COMMUNITY FOUNDATION, AND RAINWATER BASIN JOINT VENTURE (RWBJV)

Pursuant to the 2007-2012 LTPP & WC Habitat Availability Assessment Agreement (Agreement) between Rainwater Basin Joint Venture, Platte River Recovery Implementation Program, and Nebraska Community Foundation, the Amended Agreement for FY2015 is hereby amended to: 1) include a 2015 tern and plover habitat availability assessment; 2) include a 2015 whooping crane habitat availability assessment; 3) include similar deliverables for the 2015 habitat availability assessments as was specified for all other years; and 4) extend the timeframe for the project to September 30, 2017. The remaining Terms and Conditions and additional sections of the Agreement will remain as originally agreed. The Total Project Budget is also hereby amended to increase total payment under the Agreement from \$218,227 to \$268,227.

### The following Sections are hereby amended:

#### 'Deliverables and Schedule'

September 30, 2017 Final Reports and geodatabases for the 2015 LTPP and WC assessments provided to ED Office

## 'Compensation'

Compensation will occur for work in accordance with the approved scope of services and will not exceed a total of \$268,227 unless the scope and budget are modified and mutually agreed upon by the parties.

#### 'Time Frame'

The final date of the Amended Agreement shall be September 30, 2017. This time frame may be extended upon mutual agreement of the parties and pursuant to the Program.
