

# Colorado's Water Plan – Funding Strategy Talking Points and FAQs June 14, 2018

The following are general talking points and FAQs for corresponding with constituents, and other interested parties, about Colorado's Water Plan – Funding Strategy process and group.

#### **Talking Points**

**Issue:** Colorado's Water Plan (CWP) was completed in 2015 and created a blueprint for better water management in Colorado, but implementation of the plan requires sustainable funding and currently the plan has only been partially funded through a portion of the Severance Tax. The estimated funding gap is around \$100 Million per year over a 20-year period.

**About the Group:** Colorado's Water Plan - funding strategy group is an informal group that brings together a diverse set of leaders and perspectives from across Colorado to help identify a viable strategy to secure funding and implement the CWP.

**Objectives:** The group hopes to reach consensus in the following areas related to a funding strategy:

- What is needed to implement the priorities in the Colorado Water Plan;
- Proposed governance structure for distributing funds and making funding decisions;
- Proposed mechanism to provide funding.

**Timeline:** The group will meet four times over the summer. Once a strategy has been identified the group will discuss additional engagement strategies and the groups best suited to carry the work forward.

**Funding Source:** The proposed mechanism for funding the Water Plan has not been identified but may include: private funds, public funds, tax revenue, fees, or other sources of revenue.

**Getting Involved:** The group is not currently looking to expand the number of participants, however, there are other avenues for interested parties to engage and stay informed on the process. Please contact Keystone Policy Center with any questions.
