This letter puts in writing the Animas River Community Forum's (Forum) formal request for an extension of the 2016 Water Supply Reserve Account (WSRA) Grant we were awarded last year. Grant identification information is provided below.

The WSRA Grant funds awarded by the CWCB have been critically important to the Forum's operations and accomplishment in 2017 and 2018. These funds have supported to the Forum's work to connect various water users, government entities, businesses, and conservation organizations operating in the Animas River Basin since the Gold King Mine Spill on August 5, 2015.

The Forum is requesting the grant period be extended to December 31, 2018 in order to provide the time needed to finalize and disseminate the Animas Almanac (i.e., identified as a "Report" in our grant application, and is listed as a deliverable under Task 2 of our Grant application on page 15:

 Develop a report card that utilizes the lessons learned in the Community Survey to place the metrics and indicators for changes/improvement within an accessible and visually engaging format.
Publish the report and circulate it to ARCF partner organizations and networks. The Forum is not able to accomplish these tasks by April 1, 2018 for the following reasons:

We have been developing responses to ten questions related to public concerns about water health and safety using nationally accepted water quality standards supported by local monitoring data. It has taken time to build consensus about what standards are used and how to define them simply, in order for the final product to be accessible to the majority of the public. The length of the Almanac/Report has also required that we re-think how it is distributed. New ideas include limiting the number of hard copies, making the Almanac/Report accessible online; and primarily disseminating it via presentations to community groups. Disseminating the Almanac via presentations will also support our objective of the Almanac stimulating dialogue. Toward this end, four of the ten questions have been designed specifically to stimulate thinking, and the Almanac provides a list of what "you can do" to make the Animas River more resilient.

Currently, the Almanac (which has been developed by a working group of the ARC Forum) is being sent to the full ARC Forum Membership for review; it will then be sent to a printer and uploaded to the ARC Forum Webpage by May, 2018. It will then be disseminated via presentations beginning in June 2018. The Almanac is intended to have a life of approximately two years. However there are plans to capture lessons learned, for the next edition of the Almanac. We intend to update the Almanac every 2 years.

In order to fulfill the deliverable of finalizing and disseminating the Almanac/Report, as stated in our grant application, we respectfully request that the CWCB extend our grant period to December 31, 2018. By extending the grant thru December 2018, the Forum will be able to expend the remaining funds (\$24,324 as of 12/31/17) to support travel cost, materials and time associated with development and dissemination of the Almanac. As required, please see the attached revised schedule.

We sincerely appreciate your consideration of this request and would be happy to discuss any criteria or conditions of approval you deem necessary to extend the grant period and dissemination of funds.
