Introduction

In 2018, the Environment and Recreation category was appropriated \$1.5 million in funding. In the first round of fiscal year 2018-2019 applications, the CWCB received 6 applications totaling \$1,805,420. Staff recommended approval of the 5 grants totaling \$554,711, leaving \$946,289 available for future rounds of grant funding. In this second round of fiscal year 2018-2019, the CWCB received 18 applications totaling \$1,959,024. Three of these applications will be discussed in the Agriculture category and one other is being addressed through the Conservation and Land Use category. The remaining 14 are included in this agenda item. See attached data sheets for project summaries. The data sheets are grouped after the memo and again as headers to each grant application in the pages that follow.

Staff Recommendation

Staff recommends that the Board Approve the projects/activities listed in the following table for Colorado Water Plan Grant funding contingent upon the applicants' abilities to resolve issues and additional needs discussed below.

(1) Staff is recommending funding from two categories of Water Plan Grant funds. \$30,000 from the Environment and Recreation category and \$16,000 from Engagement and Innovation.

Staff Review and Comments

Staff reviewed the applications as a committee with the intent of expending remaining fiscal year 2018-2019 funds equitably on eligible projects among the basins that applied. Projects that did not receive recommendations for funding scored consistently low by the entire committee.

Project Issues/Additional Needs

- All funding awards are contingent upon the applicants' ability to secure match funding
- Grantees should adequately address CWCB staff comments to scopes of work and engineering designs (when applicable). Staff will schedule meetings with each successful applicant to discuss comments and contracting procedures

- All grantees should adhere to their organizational procurement policies when hiring contractors and consultants. CWCB recommends that State procurement policies be used as a guide if an organization does not have procurement policies.
- Project should comply with the CWCB's Rules and Regulations for Regulatory Floodplains in Colorado when applicable.
