Summary of Water Court Application

This is an application for simple change in surface point of diversion pursuant to Section 37-92-305(3.5), C.R.S. (2018).

Staff Recommendation

Staff recommends that the Board ratify the filing of a Statement of Opposition filed on behalf of the Board in April 2019 to protect CWCB's instream flow water rights.

Potential for Injury


- This application does not appear to qualify under the simple change statute.
