REQUEST FOR PREHEARING CONFERENCE DATE & DEADLINES FOR SUBMISSIONS

The Colorado Water Conservation Board ("CWCB") has designated Deputy Attorney General Amy Beatie as Hearing Officer for the contested proposed instream flow appropriation on Carnero Creek. The hearing on this matter will be held in conjunction with the CWCB's November 2019 meeting in the Denver Metro area. You will be notified of the precise time and location of the hearing once it is scheduled.

Rule 5c. of the Rules Concerning the Colorado Instream Flow and Natural Lake Level Program require the Hearing Officer to establish the date for a prehearing conference and deadlines for written submissions, designation of witnesses, and identification of exhibits. The rule requires, among other provisions, that a prehearing conference be held prior to the July CWCB Board meeting. The rule, however, provides that the CWCB "may modify . . . this schedule as it deems appropriate." Given that the hearing in this matter has been moved to the November CWCB meeting at the request of the parties, it appears that providing more time to discuss the case may be desirable. Rather than set deadlines based on the timeframes in Rule 5c., the Hearing Officer hereby requests that the parties submit a response to this request that sets out the following:

- a) the desired due date for the prehearing statement;
- b) a date and time for the prehearing conference; and
- c) the desired due date for rebuttal statements.
