1. GRANT

As of the Grant Issuance Date, the State Agency shown on the first page of this Grant Award Letter (the "State") hereby obligates and awards to Grantee shown on the first page of this Grant Award Letter (the "Grantee") an award of Grant Funds in the amounts shown on the first page of this Grant Award Letter. By accepting the Grant Funds provided under this Grant Award Letter, Grantee agrees to comply with the terms and conditions of this Grant Award Letter and requirements and provisions of all Exhibits to this Grant Award Letter.

2. TERM

A. Initial Grant Term and Extension

The Parties' respective performances under this Grant Award Letter shall commence on the Grant Issuance Date and shall terminate on the Grant Expiration Date unless sooner terminated or further extended in accordance with the terms of this Grant Award Letter. Upon request of Grantee, the State may, in its sole discretion, extend the term of this Grant Award Letter by providing Grantee with an updated Grant Award Letter showing the new Grant Expiration Date.

B. Early Termination in the Public Interest

The State is entering into this Grant Award Letter to serve the public interest of the State of Colorado as determined by its Governor, General Assembly, or Courts. If this Grant Award Letter ceases to further the public interest of the State or if State or other funds used for this Grant Award Letter are not appropriated, or otherwise become unavailable to fund this Grant Award Letter, the State, in its discretion, may terminate this Grant Award Letter in whole or in part by providing written notice to Grantee that includes, to the extent practicable, the public interest justification for the termination. If the State terminates this Grant Award Letter in the public interest, the State shall pay Grantee an amount equal to the percentage of the total reimbursement payable under this Grant Award Letter that corresponds to the percentage of Work satisfactorily completed, as determined by the State, less payments previously made. Additionally, the State, in its discretion, may reimburse Grantee for a portion of actual, out-of-pocket expenses not otherwise reimbursed under this Grant Award Letter that are incurred by Grantee and are directly attributable to the uncompleted portion of Grantee's obligations, provided that the sum of any and all reimbursements shall not exceed the maximum amount payable to Grantee hereunder. This subsection shall not apply to a termination of this Grant Award Letter by the State for breach by Grantee.

3. **DEFINITIONS**

The following terms shall be construed and interpreted as follows:

- A. "Budget" means the budget for the Work described in Exhibit B.
- B. "Business Day" means any day in which the State is open and conducting business, but shall not include Saturday, Sunday or any day on which the State observes one of the holidays listed in §24-11-101(1) C.R.S.
- C. "CORA" means the Colorado Open Records Act, §§24-72-200.1 et. seq., C.R.S.

- D. "Grant Award Letter" means this letter which offers Grant Funds to Grantee, including all attached Exhibits, all documents incorporated by reference, all referenced statutes, rules and cited authorities, and any future updates thereto.
- E. "Grant Funds" means the funds that have been appropriated, designated, encumbered, or otherwise made available for payment by the State under this Grant Award Letter.
- F. "Grant Expiration Date" means the Grant Expiration Date shown on the first page of this Grant Award Letter.
- G. "Grant Issuance Date" means the Grant Issuance Date shown on the first page of this Grant Award Letter.
- H. "Exhibits" exhibits and attachments included with this Grant as shown on the first page of this Grant
- I. "Extension Term" means the period of time by which the Grant Expiration Date is extended by the State through delivery of an updated Grant Award Letter

- P. "Services" means the services to be performed by Grantee as set forth in this Grant Award Letter, and shall include any services to be rendered by Grantee in connection with the Goods.
- Q. "State Confidential Information" means any and all State Records not subject to disclosure under CORA. State Confidential Information shall include, but is not limited to, PII, and State personnel records not subject to disclosure under CORA. State Confidential Information shall not include information or data concerning individuals that is not deemed confidential but nevertheless belongs to the State, which has been communicated, furnished, or disclosed by the State to Contractor which (i) is subject to disclosure pursuant to CORA; (ii) is already known to Contractor without restrictions at the time of its disclosure to Contractor; (iii) is or subsequently becomes publicly available without breach of any obligation owed by Contractor to the State; (iv) is disclosed to Contractor, without confidentiality obligations, by

- a third party who has the right to disclose such information; or (v) was independently developed without reliance on any State Confidential Information.
- R. "State Fiscal Rules" means the fiscal rules promulgated by the Colorado State Controller pursuant to §24-30-202(13)(a) C.R.S.
- S. "State Fiscal Year" means a 12 month period beginning on July 1 of each calendar year and ending on June 30 of the following calendar year. If a single calendar year follows the term, then it means the State Fiscal Year ending in that calendar year.
- T. "State Records" means any and all State data, information, and records, regardless of physical form, including, but not limited to, information subject to disclosure under CORA.
- U. "Subcontractor" means third-parties, if any, engaged by Grantee to aid in performance of the Work. "Subcontractor" also includes sub-grantees.
- V. "Work" means the delivery of the Goods and performance of the Services described in this Grant Award Letter.
- W. "Work Product" means the tangible and intangible results of the Work, whether finished or unfinished, including drafts. Work Product includes, but is not limited to, documents, text, software (including source code), research, reports, proposals, specifications, plans, notes, studies, data, images, photographs, negatives, pictures, drawings, designs, models, surveys, maps, materials, ideas, concepts, know-how, and any other results of the Work. "Work Product" does not include any material that was developed prior to the Grant Issuance Date that is used, without modification, in the performance of the Work.

Any other term used in this Grant Award Letter that is defined in an Exhibit shall be construed and interpreted as defined in that Exhibit.

4. STATEMENT OF WORK

Grantee shall complete the Work as described in this Grant Award Letter and in accordance with the provisions of Exhibit A. The State shall have no liability to compensate or reimburse Grantee for the delivery of any goods or the performance of any services that are not specifically set forth in this Grant Award Letter.

5. PAYMENTS TO GRANTEE

A. Maximum Amount

Payments to Grantee are limited to the unpaid, obligated balance of the Grant Funds. The State shall not pay Grantee any amount under this Grant that exceeds the Grant Amount shown on the first page of this Grant Award Letter. Financial obligations of the State payable after the current State Fiscal Year are contingent upon funds for that purpose being appropriated, budgeted, and otherwise made available. The State shall not be liable to pay or reimburse Grantee for any Work performed or expense incurred before the Grant Issuance Date or after the Grant Expiration Date.

Grantee shall provide the Local Match Amount shown on the first page of this Grant Award Letter and described in Exhibit A (the "Local Match Amount"). Grantee shall appropriate and allocate all Local Match Amounts to the purpose of this Grant Award Letter each fiscal year prior to accepting any Grant Funds for that fiscal year. Grantee does not by accepting this Grant Award Letter irrevocably pledge present cash reserves for payments in future fiscal years, and this Grant Award Letter is not intended to create a multiple-fiscal year debt of

Grantee. Grantee shall not pay or be liable for any claimed interest, late charges, fees, taxes or penalties of any nature, except as required by Grantee's laws or policies.

D. Reimbursement of Grantee Costs

The State shall reimburse Grantee's allowable costs, not exceeding the maximum total amount described in this Grant Award Letter for all allowable costs described in this Grant Award Letter and shown in the Budget, except that Grantee may adjust the amounts between each line item of the Budget without formal modification to this Agreement as long as the Grantee provides notice to the State of the change, the change does not modify the total maximum amount of this Grant Award Letter or the maximum amount for any state fiscal year, and the change does not modify any requirements of the Work. The State shall only reimburse allowable costs if those costs are: (i) reasonable and necessary to accomplish the Work and for the Goods and Services provided; and (ii) equal to the actual net cost to Grantee (i.e. the price paid minus any items of value received by Grantee that reduce the cost actually incurred).

E. Close-Out.

Grantee shall close out this Grant within 45 days after the Grant Expiration Date. To complete close out, 'Grantee shall submit to the State all deliverables (including documentation) as defined in this Grant Award Letter and Grantee's final reimbursement request or invoice. The State will withhold 5% of allowable costs until all final documentation has been submitted and accepted by the State as substantially complete.

6. REPORTING - NOTIFICATION

A. Performance and Final Status

Grantee shall submit all financial, performance and other reports to the State no later than the end of the close out described in §5.E, containing an evaluation and review of Grantee's performance and the final status of Grantee's obligations hereunder.

B. Violations Reporting

Grantee shall disclose, in a timely manner, in writing to the State all violations of State criminal law involving fraud, bribery, or gratuity violations. The State may impose any penalties for noncompliance which may include, without limitation, suspension or debarment.

7. GRANTEE RECORDS

A. Maintenance and Inspection

Grantee shall make, keep, and maintain, all records, documents, communications, notes and other written materials, electronic media files, and communications, pertaining in any manner to this Grant for a period of three years following the completion of the close out of this Grant. Grantee shall permit the State to audit, inspect, examine, excerpt, copy and transcribe all such records during normal business hours at Grantee's office or place of business, unless the State determines that an audit or inspection is required without notice at a different time to protect the interests of the State.

B. Monitoring

The State will monitor Grantee's performance of its obligations under this Grant Award Letter using procedures as determined by the State. The State shall have the right, in its sole

discretion, to change its monitoring procedures and requirements at any time during the term of this Agreement. The State shall monitor Grantee's performance in a manner that does not unduly interfere with Grantee's performance of the Work.

C. Final Audit Report

Grantee shall promptly submit to the State a copy of any final audit report of an audit performed on Grantee's records that relates to or affects this Grant or the Work, whether the audit is conducted by Grantee or a third party.

8. CONFIDENTIAL INFORMATION-STATE RECORDS

A. Confidentiality

Grantee shall hold and maintain, and cause all Subcontractors to hold and maintain, any and all State Records that the State provides or makes available to Grantee for the sole and exclusive benefit of the State, unless those State Records are otherwise publically available at the time of disclosure or are subject to disclosure by Grantee under CORA. Grantee shall not, without prior written approval of the State, use for Grantee's own benefit, publish, copy, or otherwise disclose to any third party, or permit the use by any third party for its benefit or to the detriment of the State, any State Records, except as otherwise stated in this Grant Award Letter. Grantee shall provide for the security of all State Confidential Information in accordance with all policies promulgated by the Colorado Office of Information Security and all applicable laws, rules, policies, publications, and guidelines. If Grantee or any of its Subcontractors will or may receive the following types of data, Grantee or its Subcontractors shall provide for the security of such data according to the following: (i) the most recently promulgated IRS Publication 1075 for all Tax Information and in accordance with the Safeguarding Requirements for Federal Tax Information attached to this Grant as an Exhibit, if applicable, (ii) the most recently updated PCI Data Security Standard from the PCI Security Standards Council for all PCI, (iii) the most recently issued version of the U.S. Department of Justice, Federal Bureau of Investigation, Criminal Justice Information Services Security Policy for all CJI, and (iv) the federal Health Insurance Portability and Accountability Act for all PHI and the HIPAA Business Associate Agreement attached to this Grant, if applicable. Grantee shall immediately forward any request or demand for State Records to the State's principal representative.

B. Other Entity Access and Nondisclosure Agreements

Grantee may provide State Records to its agents, employees, assigns and Subcontractors as necessary to perform the Work, but shall restrict access to State Confidential Information to those agents, employees, assigns and Subcontractors who require access to perform their obligations under this Grant Award Letter. Grantee shall ensure all such agents, employees, assigns, and Subcontractors sign nondisclosure agreements with provisions at least as protective as those in this Grant, and that the nondisclosure agreements are in force at all times the agent, employee, assign or Subcontractor has access to any State Confidential Information. Grantee shall provide copies of those signed nondisclosure restrictions to the State upon request.

C. Use, Security, and Retention

Grantee shall use, hold and maintain State Confidential Information in compliance with any and all applicable laws and regulations in facilities located within the United States, and shall maintain a secure environment that ensures confidentiality of all State Confidential Information wherever located. Grantee shall provide the State with access, subject to

Grantee's reasonable security requirements, for purposes of inspecting and monitoring access and use of State Confidential Information and evaluating security control effectiveness. Upon the expiration or termination of this Grant, Grantee shall return State Records provided to Grantee or destroy such State Records and certify to the State that it has done so, as directed by the State. If Grantee is prevented by law or regulation from returning or destroying State Confidential Information, Grantee warrants it will guarantee the confidentiality of, and cease to use, such State Confidential Information.

D. Incident Notice and Remediation

If Grantee becomes aware of any Incident, it shall notify the State immediately and cooperate with the State regarding recovery, remediation, and the necessity to involve law enforcement, as determined by the State. After an Incident, Grantee shall take steps to reduce the risk of incurring a similar type of Incident in the future as directed by the State, which may include, but is not limited to, developing and implementing a remediation plan that is approved by the State at no additional cost to the State.

E. Safeguarding PII

If Grantee or any of its Subcontractors will or may receive PII under this Agreement, Grantee shall provide for the security of such PII, in a manner and form acceptable to the State, including, without limitation, State non-disclosure requirements, use of appropriate technology, security practices, computer access security, data access security, data storage encryption, data transmission encryption, security inspections, and audits. Grantee shall be a "Third-Party Service Provider" as defined in §24-73-103(1)(i), C.R.S. and shall maintain security procedures and practices consistent with §§24-73-101 et seq., C.R.S.

9. CONFLICTS OF INTEREST

Grantee shall not engage in any business or activities, or maintain any relationships that conflict in any way with the full performance of the obligations of Grantee under this Grant. Grantee acknowledges that, with respect to this Grant, even the appearance of a conflict of interest shall be harmful to the State's interests and absent the State's prior written approval, Grantee shall refrain from any practices, activities or relationships that reasonably appear to be in conflict with the full performance of Grantee's obligations under this Grant. If a conflict or the appearance of a conflict arises, or if Grantee is uncertain whether a conflict or the appearance of a conflict has arisen, Grantee shall submit to the State a disclosure statement setting forth the relevant details for the State's consideration.

10. INSURANCE

Grantee shall maintain at all times during the term of this Grant such liability insurance, by commercial policy or self-insurance, as is necessary to meet its liabilities under the Colorado Governmental Immunity Act, §24-10-101, et seq., C.R.S. (the "GIA"). Grantee shall ensure that any Subcontractors maintain all insurance customary for the completion of the Work done by that Subcontractor and as required by the State or the GIA.

11. REMEDIES

In addition to any remedies available under any exhibit to this Grant Award Letter, if Grantee fails to comply with any term or condition of this Grant, the State may terminate some or all of this Grant and require Grantee to repay any or all Grant funds to the State in the State's sole discretion. The State may also terminate this Grant Award Letter at any time if the State has determined, in

its sole discretion, that Grantee has ceased performing the Work without intent to resume performance, prior to the completion of the Work.

12. DISPUTE RESOLUTION

Except as herein specifically provided otherwise, disputes concerning the performance of this Grant that cannot be resolved by the designated Party representatives shall be referred in writing to a senior departmental management staff member designated by the State and a senior manager or official designated by Grantee for resolution.

13. NOTICES AND REPRESENTATIVES

Each Party shall identify an individual to be the principal representative of the designating Party and shall provide this information to the other Party. All notices required or permitted to be given under this Grant Award Letter shall be in writing, and shall be delivered either in hard copy or by email to the representative of the other Party. Either Party may change its principal representative or principal representative contact information by notice submitted in accordance with this §13.

14. RIGHTS IN WORK PRODUCT AND OTHER INFORMATION

Grantee hereby grants to the State a perpetual, irrevocable, non-exclusive, royalty free license, with the right to sublicense, to make, use, reproduce, distribute, perform, display, create derivatives of and otherwise exploit all intellectual property created by Grantee or any Subcontractors or Subgrantees and paid for with Grant Funds provided by the State pursuant to this Grant.

15. GOVERNMENTAL IMMUNITY

Liability for claims for injuries to persons or property arising from the negligence of the Parties, their departments, boards, commissions committees, bureaus, offices, employees and officials shall be controlled and limited by the provisions of the Colorado Governmental Immunity Act, §24-10-101, et seq., C.R.S.; the Federal Tort Claims Act, 28 U.S.C. Pt. VI, Ch. 171 and 28 U.S.C. 1346(b), and the State's risk management statutes, §§24-30-1501, et seq. C.R.S. No term or condition of this Contract shall be construed or interpreted as a waiver, express or implied, of any of the immunities, rights, benefits, protections, or other provisions, contained in these statutes.

16. GENERAL PROVISIONS

A. Assignment

Grantee's rights and obligations under this Grant are personal and may not be transferred or assigned without the prior, written consent of the State. Any attempt at assignment or transfer without such consent shall be void. Any assignment or transfer of Grantee's rights and obligations approved by the State shall be subject to the provisions of this Grant Award Letter.

B. Captions and References

The captions and headings in this Grant Award Letter are for convenience of reference only, and shall not be used to interpret, define, or limit its provisions. All references in this Grant Award Letter to sections (whether spelled out or using the § symbol), subsections, exhibits or other attachments, are references to sections, subsections, exhibits or other attachments contained herein or incorporated as a part hereof, unless otherwise noted.

C. Entire Understanding

This Grant Award Letter represents the complete integration of all understandings between the Parties related to the Work, and all prior representations and understandings related to the Work, oral or written, are merged into this Grant Award Letter.

D. Modification

The State may modify the terms and conditions of this Grant by issuance of an updated Grant Award Letter, which shall be effective if Grantee accepts Grant Funds following receipt of the updated letter. The Parties may also agree to modification of the terms and conditions of the Grant in a formal amendment to this Grant, properly executed and approved in accordance with applicable Colorado State law and State Fiscal Rules.

E. Statutes, Regulations, Fiscal Rules, and Other Authority.

Any reference in this Grant Award Letter to a statute, regulation, State Fiscal Rule, fiscal policy or other authority shall be interpreted to refer to such authority then current, as may have been changed or amended since the Grant Issuance Date. Grantee shall strictly comply with all applicable State laws, rules, and regulations in effect or hereafter established, including, without limitation, laws applicable to discrimination and unfair employment practices.

Water Project Overview:

The river enhancement construction project at Las Colonias Park includes four project elements. An additional inlet channel will allow flowing water for a greater period of the year, will control flow distribution to function appropriately in the existing river system, and will avoid adverse impacts to existing aquatic habitat in the main channel of the Colorado River or any secondary channels. An extension of the existing slough will feature two boulder step structures to create step-pool morphology and provide channel grade control. Multiple habitat boulders and ribbed riffle enhancements will be installed throughout the modified secondary channel creating flow heterogeneity and aquatic habitat complexity. The streambanks of the new channels will be planted with native riparian vegetation plantings, providing erosion control, a riparian buffer, and increased habitat. Bank areas along the outside of meander bends (areas of high scour potential) will be protected by biotechnical bank stabilization consisting of vegetated natural boulder terracing. This project will restore the original intent of the existing slough by adding more flow and will also add 1.77 acres of open waters of the U.S. Simultaneously, this project will make the channel more naturalized and aesthetically pleasing.

Description of Task: Work includes but is not limited to: providing all required bonds and insurance, mobilization, erosion control, general management, demobilization, installation of temporary fencing, restoration of disturbed trail areas to pre-construction conditions, installation of crushed granite trail, furnishing, installing and removing temporary items as deemed necessary by the Contractor, establishing and removing the Contractor's offices, buildings, and other necessary facilities, obtaining, complying with, and transferring permits, providing and maintaining environmental controls for the life of the Project, establishing and maintaining access roads for the life of the Project, preparing and maintaining the Project schedule, delivering and removing the Contractor's equipment, supplies, and excess materials, and cleaning up the Site, preparing and securing approvals of submittals, preparing and providing copies of stormwater and other required reports, and installation of interpretive signage.

Site will be safe for use by park users and the workers. Including general care of water practices and best management practices.

Method/Procedure: Qualified personnel will mobilize necessary equipment, prepare project staging area and install appropriate erosion control methods at various locations on the site. Other public/worker safety methods will also be used during construction. Qualified personnel will install the trail and signage.

Task 2 - Upstream Channel Extension

Description of Task: Excavation to prepare site for channel enhancements and channel extensions. Work includes but is not limited to: General safety management, labor, equipment and materials required to demolish and remove concrete structures, steel structures, grouted rock or other items identified for removal, haul all material to be removed from the site to an appropriate disposal area, any structure damaged during the removal shall be repaired or replaced by a repair or replacement method approved by the engineer, clean up at removal sites as specified, excavating, transporting, stockpiling with BMPs, and hauling excavated material to fill areas within Project, or properly disposing offsite, placing, reworking, and compacting fill material, cross hauling material, moistening, drying, and reconditioning material, as necessary, to meet moisture-density requirements, screening or other material preparation and handling, removing and hauling deleterious materials, furnishing, installing and removing temporary water control measures as required, furnishing, transporting, and placing all rock, excavating, backfilling, subgrade preparation, channel and pool shaping, removing and disposing excavated material and debris, disposing of rejected boulders, and provide field coordination for boulder placement. Provide other related and necessary labor, equipment, and materials to complete the Work.

Method/Procedure: The upstream channel extension will be accomplished by excavating the new channel using large excavating equipment. The excess material will be moved to an approved nearby site for disposal.

Deliverable: Upon completion, the excavated channel will have continuous water flow when Colorado River flows are above 810 cubic feet per second. This excavation will enable significant flow in the channel for a much larger portion of the year than the current conditions allow. The added flow dramatically increases the area of aquatic habitat, creates recreational opportunities for river users, and enhances the natural beauty of the park. An extension of the existing slough will enhance the aquatic habitat by increasing the area of open water and creating flow complexity.

Task 3 - Channel Enhancements

Description of Task: Furnish and place boulders and stabstone for access points and furnish and install stones to create increased flow complexity and associated habitat diversity. Work includes: Furnishing, transporting, and placing all rock, excavating, backfilling, subgrade preparation, channel and pool shaping, removing and disposing excavated material and debris, disposing of rejected boulders, provide field coordination, furnishing, transporting, and placing all flagstone and bedding, excavating, backfilling, subgrade preparation, general shaping, removing and disposing excavated material and debris, disposing of rejected flagstone, general safety management, labor, equipment and materials required to demolish and remove concrete structures, steel structures, grouted rock or other items identified for removal, haul all material to be removed from the site to an appropriate disposal area, any structure damaged during the removal shall be repaired or replaced by a repair or replacement method approved by the engineer, clean up at removal sites as specified. Providing other related and necessary labor, equipment, and materials to complete the Work.

Method/Procedure: After excavation and base compaction, boulders and slabstone steps will be placed with appropriate equipment and labor to the designed grades and locations.

Deliverable: Contractor will furnish and place boulders. Individual large boulders placed at optimal locations throughout the channel will allow natural scouring, secondary eddy currents, velocity refuges, and cover. Individual stones shall be set tight, minimizing voids to create adequate pool protection and avoid foot entrapment while providing the structure that features require. These boulders are beneficial for the natural habitat, river users, and the aesthetics of the park as a whole. The completed work will significantly add to the natural beauty of the park as a whole.

Task 4 - Downstream Channel Extension

Description of Task: Excavation to prepare site for channel enhancements and channel extension including two structures, pool armoring, earthwork, and stone placement. Work includes but is not limited to: General safety management, labor, equipment and materials required to demolish and remove items identified for removal, haul all material to be removed from the site to an appropriate disposal area, any structure damaged during the removal shall be repaired or replaced by a repair or replacement method approved by the engineer, clean up at removal sites as specified, excavating, transporting, stockpiling with BMPs, and hauling excavated material to fill areas within Project, or properly disposing offsite, placing, reworking, and compacting fill material, cross hauling material, moistening, drying, and reconditioning material, as necessary, to meet moisture-density requirements, screening or

other material preparation and handling, removing and hauling deleterious materials, furnishing, installing and removing temporary water control measures as required, furnishing, forming, and placing concrete, furnishing and placing reinforcing steel, furnishing and applying curing compounds, finishing and edging concrete surfaces, sawing or tooling joints, furnishing and installing cold joint material, placing base course, providing hot and cold protection, furnishing, placing, and compacting backfill material, furnishing, transporting, and placing all bedding, subbase and base coarse materials, subgrade preparation and shaping, removing and disposing excavated material and debris, coordination with materials testing company if needed, provide field coordination for placement and construction of boulders. Providing other related and necessary labor, equipment, and materials to complete the Work.

Method/Procedure: The channel extension will be accomplished by excavating the new channel using large excavating equipment. The excess material will be moved to an approved nearby site for disposal.

Deliverable: The step-pool structures will be constructed using locally sourced natural boulders and will provide recreation opportunities for in-stream users. The structures will be stable and will not present a hazard to navigation. Multiple habitat boulders and ribbed riffle enhancements will be installed throughout the modified secondary channel creating flow heterogeneity and aquatic habitat complexity. The structures will allow for natural scouring below the installed boulder steps, form flow pools with low velocities that create cover, create flow complexity and habitat diversity, aerate the water, provide grade control and flow control for the new channel, and will add to the natural appearance of the park. Strategically placed small tight boulders along the new riverbed at the tail end of the flow pools will enhance the integrity of the new structures and pools. Individual stones shall be set tight, minimizing voids to create adequate pool protection and avoid foot entrapment while providing the structure that the step-pool features require. Upon completion, the secondary channel extension will create step-pool morphology in the new channel and provide channel grade control.

Task 5 - Planning and Design

Description of Task: Construction management services for project.

Method/Procedure: Qualified construction inspectors will be on-site at critical times to observe and inspect the construction work and methods to ensure the project is being completed as designed.

Deliverable: Designer will be contracted by the City to attend pre-construction meetings and ongoing construction meetings as well as monitor the work of the contractor to ensure its proper development per design.

Task 6 - Landscaping

Description of Task: Analysis of on-site soils, soil preparation, furnishing and installation of native and adaptive plantings, upland seeding, riparian seeding. An irrigation system will be installed to support the tree and shrub plant material throughout the site.

Method/Procedure: Qualified personnel will test existing soils throughout the site for analysis. Soil amendments will be adjusted as necessary to increase establishment and success. Landscape work will be coordinated with other tasks to ensure access for the construction and stabilization of the site. Sequence of the work will be irrigation, soil preparation, planting, native seeding and mulch or blanket stabilization. All steps of the work will be installed and inspected by qualified personnel.

Irrigation - A below ground drip irrigation system will be installed starting at a new point of connection provided by the City adjacent to the site. This system will be commercial quality and will aid in the establishment of trees and shrubs throughout the site.

Weed control - Throughout the construction process weeds will be controlled to minimize the efforts during landscape establishment. Herbicide application should be utilized to control weeds prior to construction and after initial soil preparation.

Soil preparation - Is a critical component to the success of the project and will be performed once final grade is established. The process of soil preparation will be achieved using standard agricultural equipment and hydraulic tanks. There will be several inspection check points to assure the soil preparation methods and materials are being met.

Planting - Topsoil will be imported for the planting pits on all ball and burlap and containerized plant material. A mix of 2/3 imported topsoil and 1/3 existing soil will be used for the plantings. Standard landscaping practices and details will be utilized to plant material throughout the site. Willow cuttings will be harvested during a dormant period and will be installed to a depth that reaches base flow of the river.

Native seeding and mulching - Native seeding and mulching will be applied in a hydraulic process in a specified growth medium. Uniform application throughout the site will be critical for success. Blanketed areas and areas that cannot be access with larger equipment or hoses will be broadcast seeded and covered with specified blankets.

Deliverable: A stable, healthy and establishing landscape will be provided. Through soil analysis and the proper placement of soil amendments the site will prepared in a manner to support native and adaptive plants. Plants will be placed, installed and irrigated properly throughout the site. All plants shall show vigor during establishment. Native seeding will be performed in all disturbed areas and will be uniform and at applied at specified rates.

Budget and Schedule & Reporting Requirements

This Statement of Work shall be accompanied by a combined Budget and Schedule that reflects the Tasks identified in the Statement of Work and shall be submitted to CWCB in excel format.

Progress Reports: The applicant shall provide the CWCB a progress report every 6 months, beginning from the date of issuance of a purchase order, or the execution of a contract. The progress report shall describe the status of the tasks identified in the statement of work, including a description of any major issues that have occurred and any corrective action taken to address these issues.

Final Report: At completion of the project, the applicant shall provide the CWCB a Final Report on the applicant's letterhead that:

- Summarizes the project and how the project was completed.
- Describes any obstacles encountered, and how these obstacles were overcome.
- Confirms that all matching commitments have been fulfilled.
- Includes photographs, summaries of meetings and engineering reports/designs.

The CWCB will pay out the last 10% of the budget when the Final Report is completed to the satisfaction of CWCB staff. Once the Final Report has been accepted, and final payment has been issued, the purchase order or grant will be closed without any further payment.

Payment

Performance Measures

Performance measures for this contract shall include the following:

(a) Performance standards and evaluation: Grantee will produce detailed deliverables for each task as specified. Grantee shall maintain receipts for all project expenses and documentation of the minimum in-kind contributions (if applicable) per the budget in Exhibit B. Per Water Plan Grant Guidelines, the CWCB will pay out the last 10% of the budget when the Final Report is completed to the satisfaction of CWCB staff. Once the Final Report has been accepted, and final payment has been issued, the purchase order or grant will be closed without any further payment. (b) Accountability: Per Water Plan Grant Guidelines full documentation of project progress must be submitted with each invoice for reimbursement. Grantee must confirm that all grant conditions have been complied with on each

invoice. In addition, per Water Plan Grant Guidelines, Progress Reports must be submitted at least once every 6 months. A Final Report must be submitted and approved before final project payment.

(c) Monitoring Requirements: Grantee is responsible for ongoing monitoring of project progress per Exhibit A. Progress shall be detailed in each invoice and in each Progress Report, as detailed above. Additional inspections or field consultations will be arranged as may be necessary.

(d) Noncompliance Resolution: Payment will be withheld if grantee is not current on all grant conditions. Flagrant disregard for grant conditions will result in a stop work order and cancellation of the Grant Agreement.
