This letter is to advise you that the Project referenced above will be substantially complete on October 1, 2019. In accordance with the Loan Contract, the Chilcott Ditch Company owes \$899.24 for interest accrued during the construction phase of the Project. Per your request, this amount will be rolled into the loan balance (see attached Project Expenditure Schedule).

The total amount disbursed under this contract was \$266,217.97 (\$263,582.15 plus \$2,635.82 for the 1% service fee). An adjustment of \$238,782.03 will be made to the contract for the funds no longer needed. Peg Mason, Contracts Manager, will initiate the process of amending the contract and Promissory Note. The first annual loan payment of \$17,157.88 will be due on October 1, 2020 (see attached Promissory Note and Loan Repayment Schedule).

Please note, in accordance with the Borrower's Liability Insurance Provision of the Loan Contract, a renewed insurance certificate must be submitted to the CWCB annually and a Reserve Account must be maintained during the entire repayment period.

Project Description

The Chilcott Ditch Company operates the Chilcott Ditch for the benefit of its shareholders by providing direct flow irrigation water. The ditch diverts from Fountain Creek, just north of the Town of Fountain, and water travels through the Company's eight-mile-long ditch to land under the ditch as well as to an augmentation station that measures return flow to Fountain Creek on behalf of shareholders taking delivery of their pro-rata share through the augmentation station. Over time, the streambank near the augmentation station has eroded and undercut the augmentation station flume. Structural stabilization and discharge functionality and operation of the augmentation station is complete. The Company stabilized the embankment and reconstructed the outfall and sand discharge line.
