## Introduction

The Colorado's Water Plan encourages alternatives to permanent dry-up of irrigated agriculture and to utilize alternative transfer methods (ATMs) to support a sustainable agricultural industry while addressing other water resource challenges. The CWCB's Alternative Water Transfer Methods Grant Program, established in 2007, provides resources to help develop and implement ATM projects, including research. The ATM grant program also provides resources for the "life cycle" costs of ATM projects including project operations and infrastructure. The current focus of the ATM grant program is on implementing projects that will result in or facilitate actual wet-water transfers to support multiple uses, including municipal, industrial, agricultural, environmental, and recreational needs. ATM grants can also be utilized to explore alternative approaches to mandatory curtailment resulting from groundwater administration or compact compliance.

Since the ATM grant program's inception, the CWCB Board has approved 34 grants. Through these ATM grant projects, CWCB and others have studied barriers to alternative water transfer methods and supported several pilot projects across the state. The success of these pilot projects have encouraged further adoption of ATM projects, have provided the water community with valuable information on ATM development, and have influenced the adoption of policy changes to facilitate ATM implementation.

The current balance of the ATM grant program is \$1,223,518. CWCB staff, due to anticipated high demand for program funds in fiscal year 2020, is recommending a refresh of ATM funds of \$750,000 to be included in the 2020 Projects Bill. The demand is a result of more ATM projects being implemented statewide and marketing ATM success stories.

## Staff Recommendation

Staff recommends the Board approve a \$750,000 Non-Reimbursable Investment for ATM Grant Program to be included in the 2020 Projects Bill.
