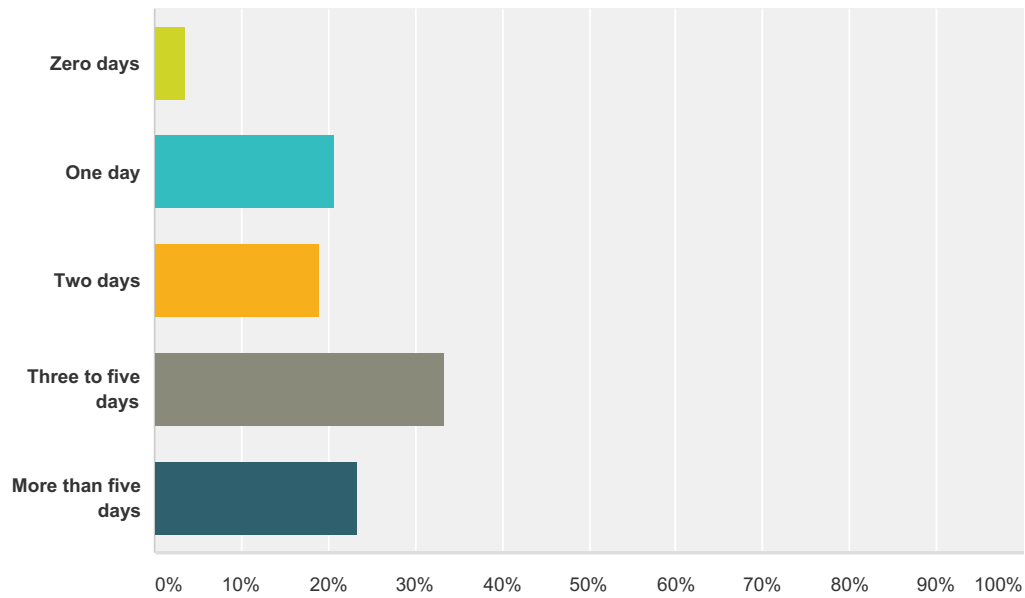

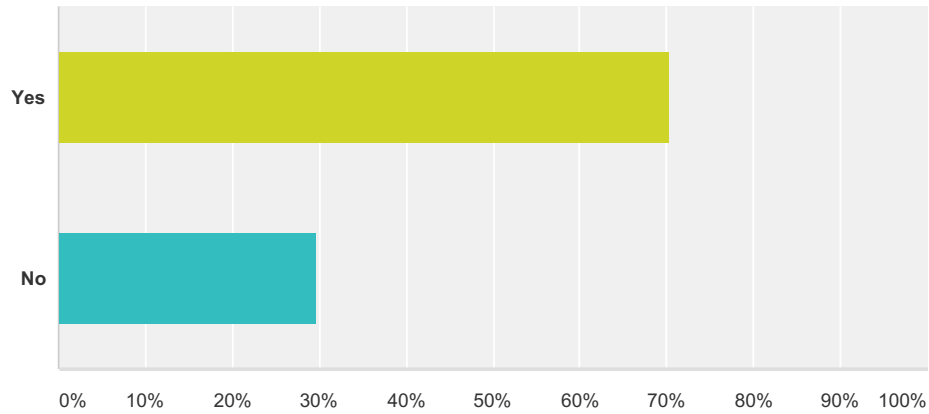

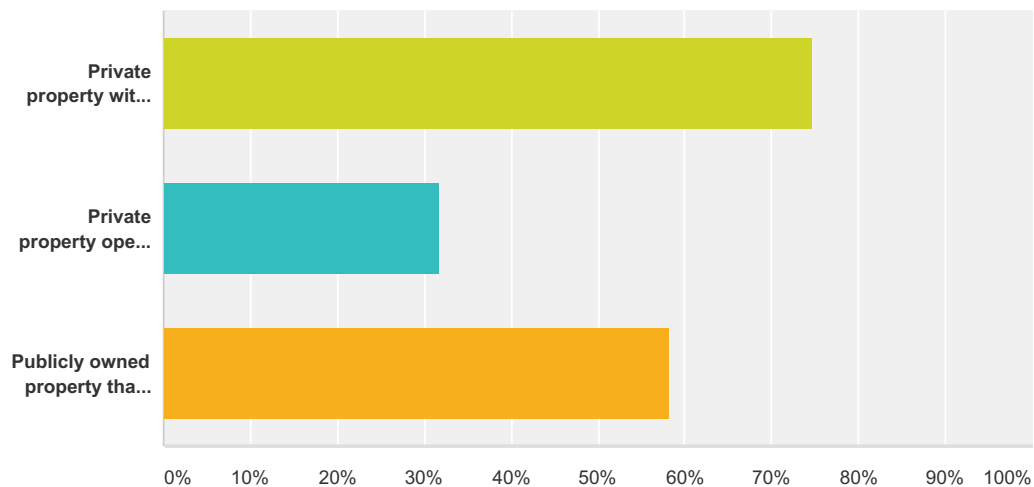

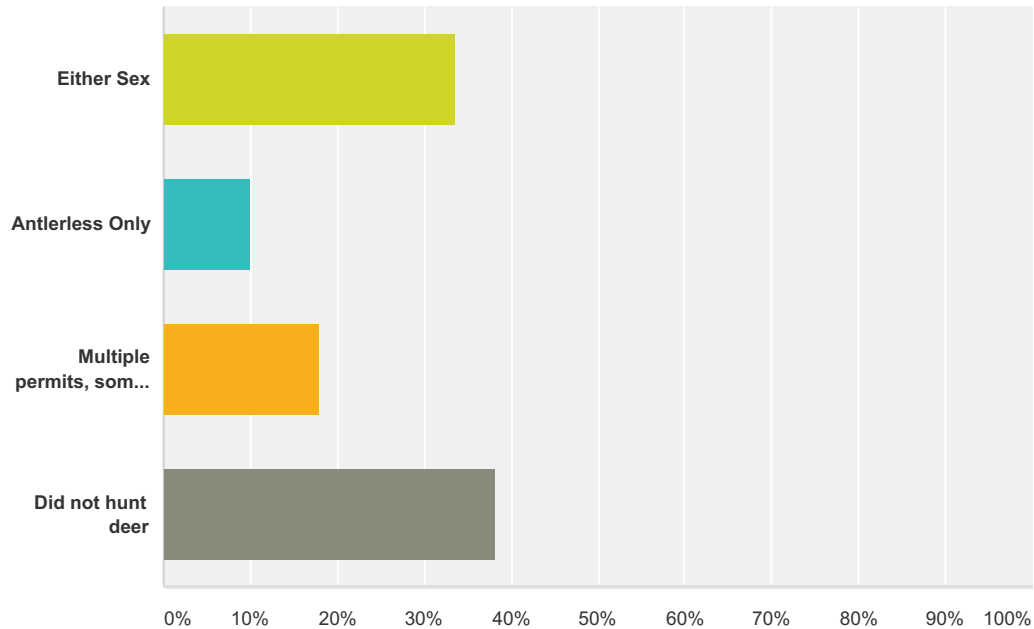

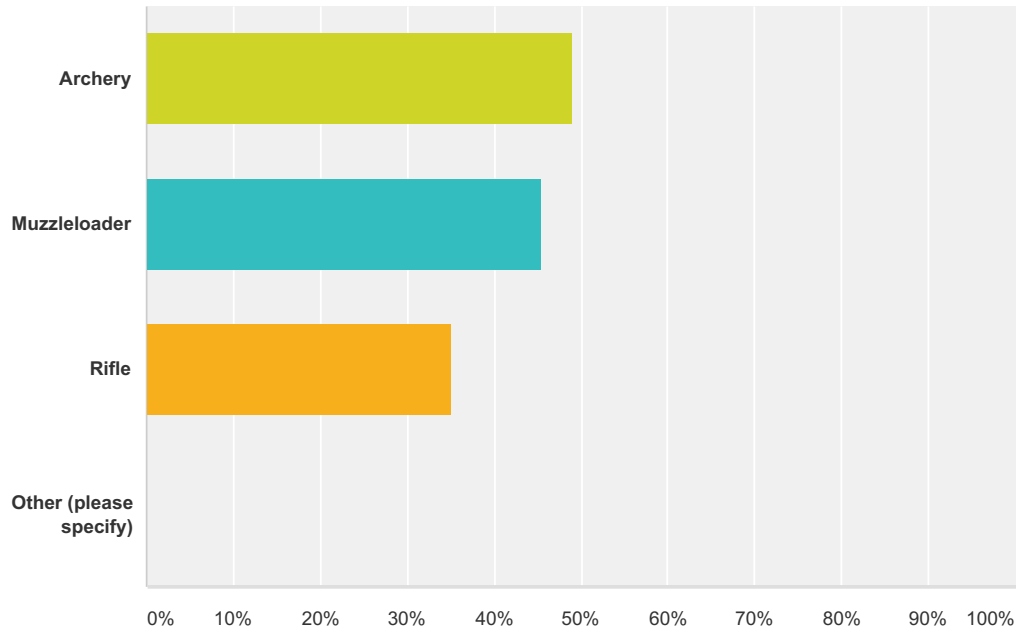

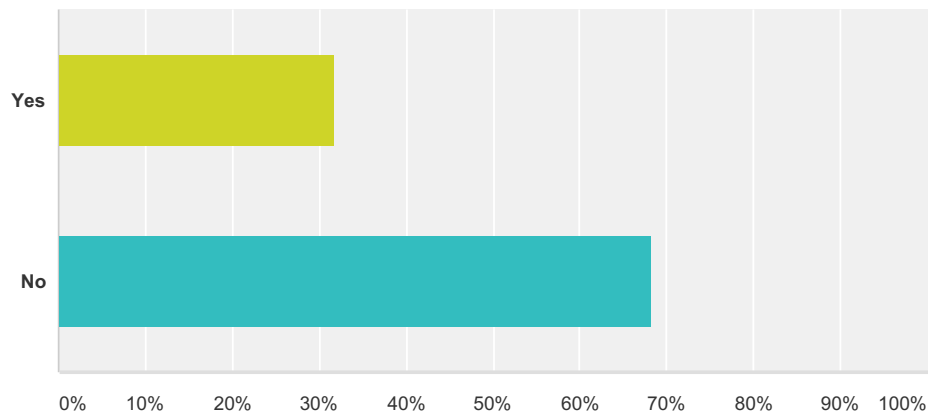

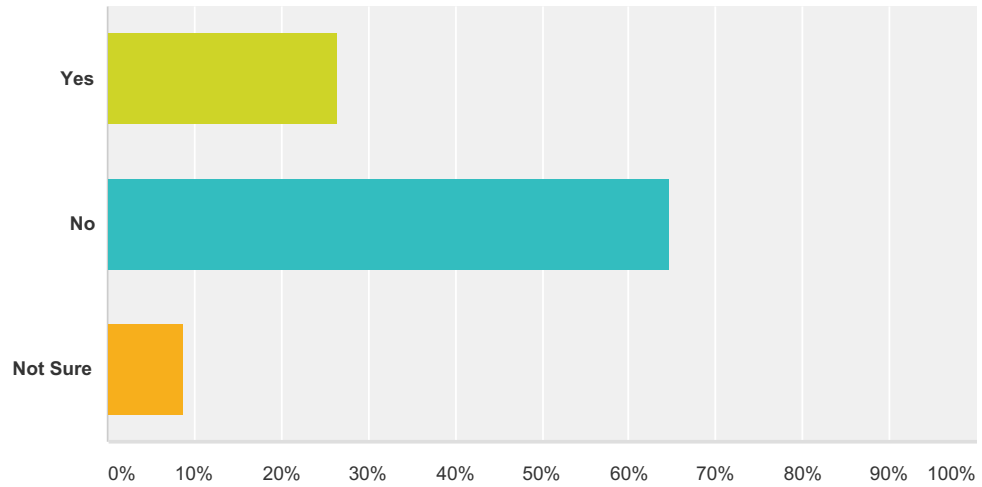

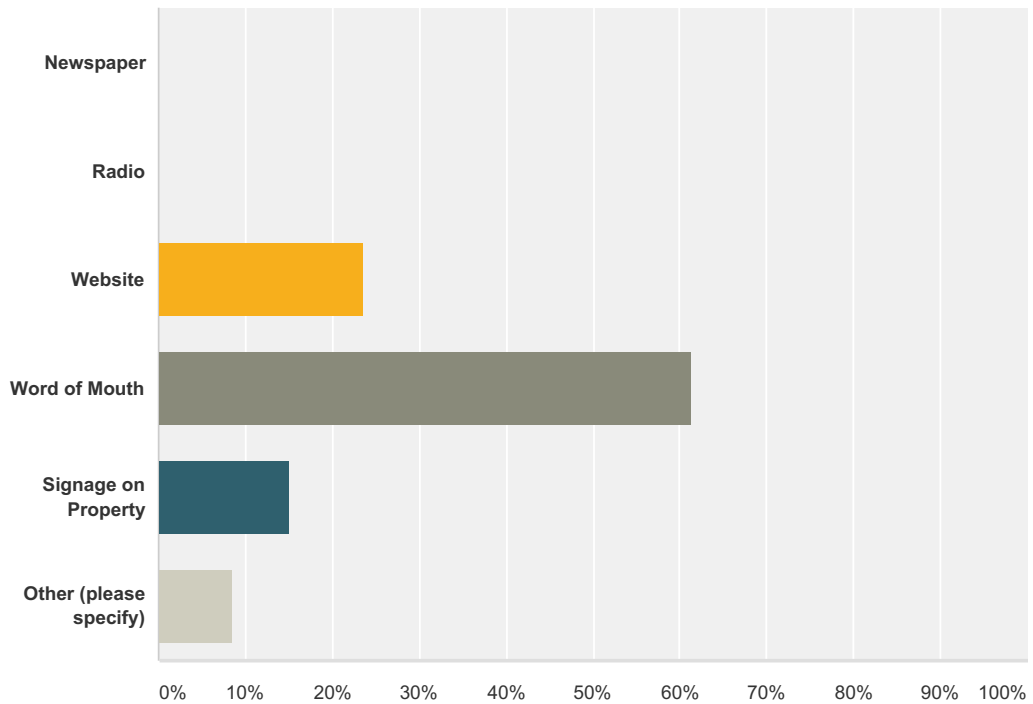

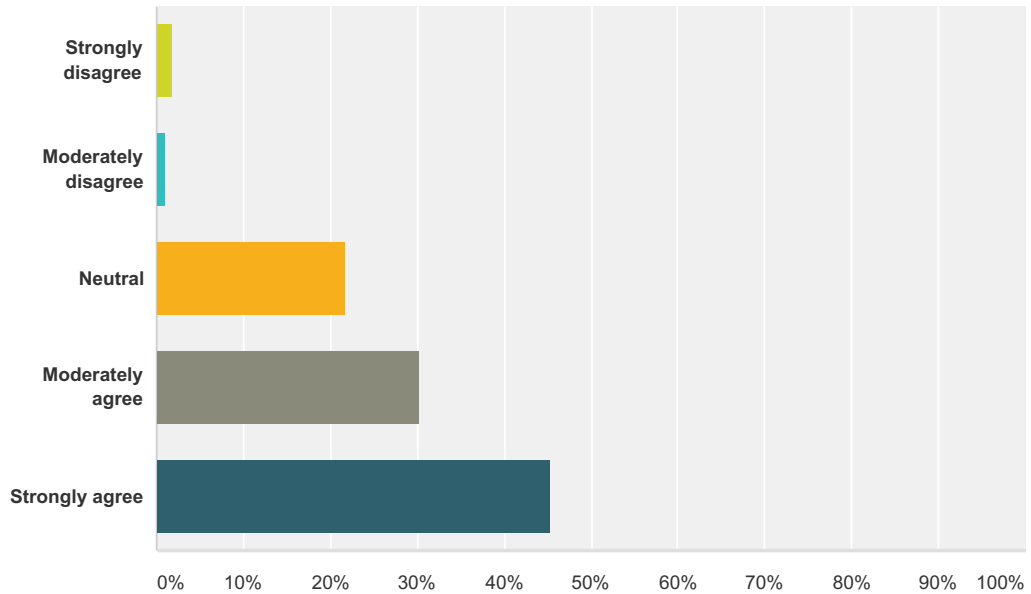

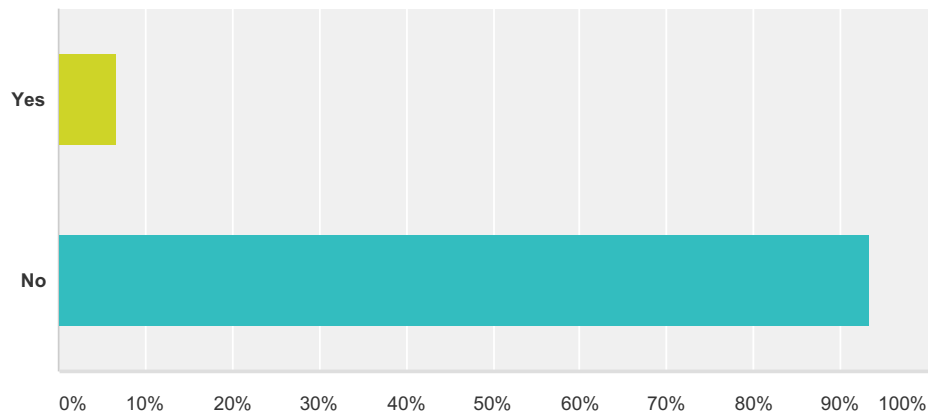

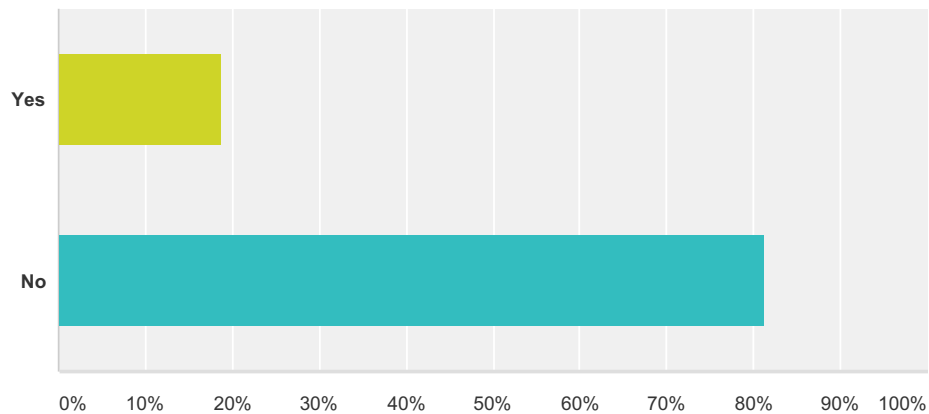

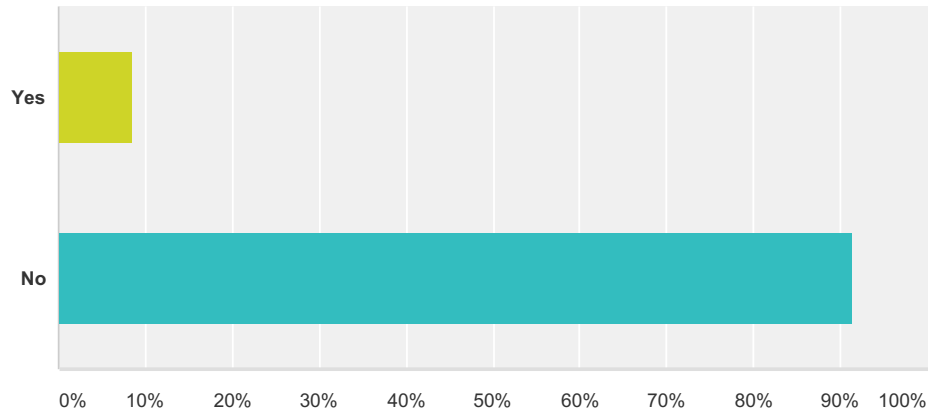

-Properties are owned by Platte River Recovery Implementation Program and managed for the benefit of threatened and endangered species: Whooping Crane, Least Tern, and Piping Plover.

-Recreation access is managed by Nebraska Game and Parks. Access is allowed during periods when it won't interfere with target species.

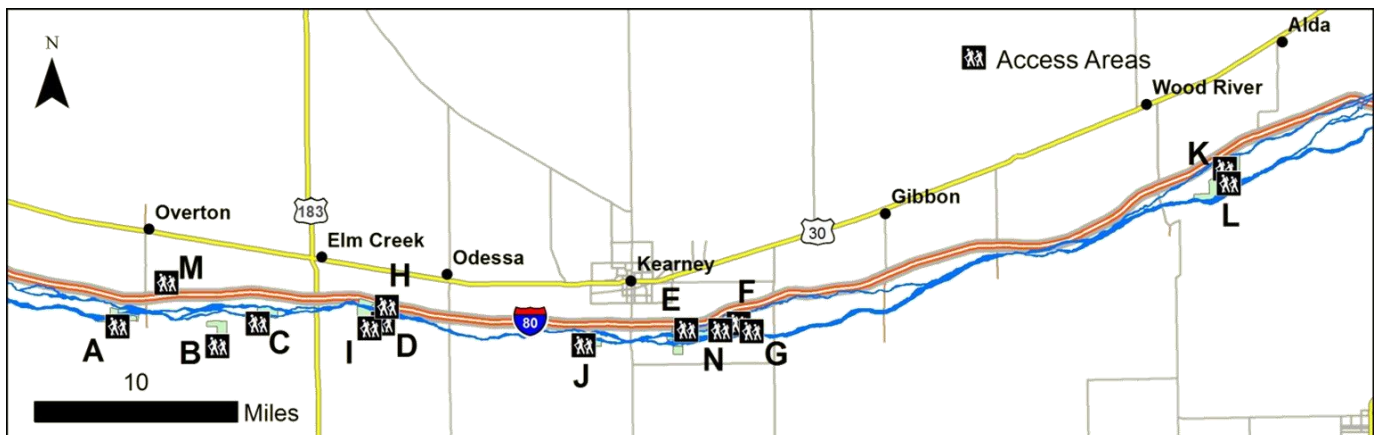
