





14. <u>Burden of Proof</u>: The CWCB has complied with all requirements and has met its burden of proof to adjudicate the water rights required in the Application and is therefore entitled to a decree approving the requested water rights.

RULING OF REFEREE

15. The foregoing Findings of Fact and Conclusions of Law are hereby approved and incorporated as the Ruling of the Referee by this reference.

16. The Application is granted and a decree for instream flow in the amount of 0.4 c.f.s. (09/01-03/31); 1.0 c.f.s. (04/01-06/30); and 0.55 c.f.s. (07/01-08/31), absolute, is hereby entered to preserve the natural environment to a reasonable degree in the natural stream channel of Bonnett Creek from its headwaters to the confluence with the Cucharas River, described in paragraph 7 above. The appropriation date for this water right is January 29, 2019.

17. The priority herein confirmed was filed in the Water Court in the year of 2019 and shall be junior to all priorities filed in previous years. 18. The CWCB shall install and maintain such measuring devices and keep such records as the Division Engineer for Water Division 2 may require for administration of this right.

It is further **ORDERED** that a copy of this Ruling of the Referee shall be filed with the Division Engineer for Water Division 2 and the State Engineer.




