CWCB Board meeting: September 16 and 17. Finance Committee meeting on September 15<sup>th</sup>. These meetings are virtual.

Megan Holcomb has been working with the drought task force, especially with the Ag community. The have created a virtual drought tour. This can be found online at: www.engagecwcb.org. You can add your story, with pictures and a pin in a map, which will inform others and feed that info back up to the drought task force.

WSRF criteria changes are in process. They will address some long-needed changes:

- 1. Language changes that clarify. Updated terminology and grammatical edits.
- 2. As basins have tried to streamline meetings, they have pushed roundtable-level grant approvals to the same time of year before the September and March CWCB meetings. This has created a bottleneck at the staff level, making it more difficult to process all of the applications in a timely fashion. The CWCB would like to move the deadline up a month, so there are two months for staff review and approval.
- 3. Historically, basin funds have been released over the year, in a 40/30/30 distribution. CWCB would like to release 100% of funding earlier in the year, on September 1, which is when the funds become available.

Keep in mind that there is a forecast of no funding through severance tax in the next three years.

CWCB staff is working from home through January 1. We expect Safer At Home, which is expiring this month, to shift a bit. Four layers that apply different rules depending on what gradient you are in. DNR may lag behind state changes – because of budget shortfalls, meeting virtually is less expensive that meeting in person.

BIP updates are rolling along. All other RTs are in a similar position to the Arkansas Basin. Staff are working on how the water plan update feeds into the BIP updates. There is a lot of group interest in some areas. Building our own work plan around concepts that will get explored. Russ mentioned Abby Burke's work on rapid river health assessments. It may not be a one size fits all. CWCB isn't necessarily supporting her specific way to prioritize goals that are in the water plan but is interested.

Greg Felt: Greg is looking forward to the finance meeting next Tuesday afternoon, in order to get a better idea of what capacity is going to be. The Demand Management workshop on the 2<sup>nd</sup> was a great experience for Greg. There is a daunting array of issues to consider and address in any plan moving forward.

Forest Health is a topic that Greg expects to be very engaged in for the next few years. Our water infrastructure is designed to work within a healthy forest, and when the forest is compromised, so is that infrastructure. We are unique in that our view of forest health is watershed-wide.

## Needs Assessment - Mike Weber

Current approved applications will be considered at the upcoming CWCB meeting.

Water Plan grant applications will go into a new, annual cycle for approval.

Four Arkansas Basin WSRF grants will be heard at the CWCB meeting. \$89,900 from basin funds. \$617,900 from statewide funds. The Arkansas Basin has \$412,000 now, so after CWCB approval of these four grants, we'll have \$322,000 remaining. There is \$5.7 million in statewide funds, which will be spread out at \$1.9 million per year for the next three years.

## Environment/Recreation Committee - Bob Hamel, Rena Griggs, Amber Shanklin

Elise will begin disseminating Enviro-Rec meeting notes as a thorough report out from the committee. Rena gave a CPW update – they are shuttling some water accounts around. Released 170 acre-feet from Lake Pueblo to John Martin. Rena announced CPW's desire for others to help put more water into that permanent pool. It must be trans-mountain water. Regarding Two Buttes Reservoir in Baca County, CPW is starting work to replace two gates at the dam.

Forest service and BLM are also working on updates to the BIP. They'll be pulling out quite a few of the projects that they plan to work on in-house.

Rena notes that this summer the forest got trashed. Public use records were set for campgrounds and use of parks and forest service lands was greatly increased during the Covid19 shut-down. Remediation is needed due to heavy use of parks and open forest lands.

### **Arkansas River Watershed Collaborative – Carol Ekarius**

Carol Ekarius will be stepping back into a management role of ARWC for the time being. Mark welcomed her back. We have some governance questions that we'll be discussing with the Board of Directors and with CWCB before deciding how to move forward.

## **Project Updates:**

- Monarch Pass Steep Slope Mitigation Project moving forward. Equipment is mobilizing as we speak. Working with Miller Timber and the Forest Service. Sam Ebersole will be doing some footage of the project. 2-year project. Forest service may add money. That would allow for more work on steep slopes.
- Hayden Pass Fire wrapping up that project. Did a lot of work on the ground last year. Looking at longerterm recovery projects, like habitat restoration. Putting together a case study that can be used by others for post-fire recovery, possibly nationwide.
- Science Plan need to develop a final report. Where does it lead us in the future? Wrapping that up in the next couple of months.

- Phone interviews with municipal water providers (43) and past ATM participants (14)
- ATM Advisory Committee

Review of 54 studies and report related to ATMs compiled in a literature review.

### **Key Findings:**

- 30,000 acre-feet towards 50,000 acre-feet goal
- Municipal barriers are large, but interest remains in maintaining community buffers, conservation of open lands, supporting ag neighbors and promoting food awareness among citizens.

# Conceptual Elements of Defining ATMs

- Looking at the intersection of these:
  - Water transfer purpose
  - Avoid & limit dry up
  - CO water plan objectives

### **Issues of Greatest Concern**

- 1. Definition of ATM's created criteria to define ATM transactions (required and preferred criteria)
- 2. Tracking metrics
- 3. Role of ATM's in ag dry-up

Proposed Metrics to Track Progress on ATMs

### Recommendations

# Funding:

- Maintain ATM grant program
- Incentivize ATM projects under existing CWCB funding programs
  - Projects could add ATM feasibility components (does a proposed project facilitate future ATMs?)
- Fund and support applications that address agricultural dry-up Policy:
- Define ATM's
- Reduce Regulatory Uncertainty
  - Allow/encourage flexible dry-up agreements for lands with alternative water sources.
- Agency Coordination
  - State CWCB and DNR
  - o Federal Work with USDA to expand crop insurance allowances for limited irrigation.

## Education:

- ATM website. Landing source for all things ATM's.
- Provide support/training for local facilitators.
- Expand resources for municipal water providers.
- Basin Roundtable consider forming ATM task forces.
