ORDER GRANTING UNOPPOSED MOTION TO VACATE HEARING

THIS MATTER comes before the Hearing Officer on the Staff of the Colorado Water Conservation Board's ("CWCB Staff") motion to vacate the hearing currently scheduled during the Colorado Water Conservation Board's ("CWCB") November 18-19, 2020 meeting. The Hearing Officer, having reviewed the motion and being otherwise adequately advised, hereby GRANTS the motion.

CWCB Staff and Knott Land and Livestock Company, Inc. entered into a Stipulation and Agreement on October 19, 2020.

CWCB Staff and Twenty Mile Coal, LLC entered into a Stipulation and Agreement on October 19, 2020.

Thus, no parties currently remain who contest the instream flow appropriation, and therefore no hearing is necessary in this matter. If the CWCB rejects the terms and conditions contained in the Stipulations and Agreements recommended by CWCB Staff, the Hearing Officer will work with the parties to reschedule the hearing, if necessary.

The hearing in this matter set for November 18-19, 2020 is hereby VACATED.
