Below is a summary of the requested homework action items that are explained in the link above.

1. Review the final draft Themes, Undercurrents, and Goals

The Next Steps Committee reviewed and commented on the draft of the Themes, Undercurrents, and Goals, and has recommended that the Roundtable approve this final draft. During the 3/29/2021 meeting, the Roundtable will vote whether or not to approve the Themes, Undercurrents, and Goals. Please review the final draft before the Roundtable votes.

2. Review the draft Strategies

Strategies are intended to answer the question of "How can the Basin make progress toward its Goals and achieve the Basin's vision?" Please review the draft Strategies and provide feedback if you have any.

3. Review the Focus Area Maps for Stream Prioritization

The purpose of the Focus Area mapping task is to support the Colorado Basin Roundtable's identification of priority streams and sub-basins. Please review the maps, and:

- a. be prepared to share thoughts and ideas regarding the usefulness of this information to select priority streams
- b. be prepared to share top three priority streams/Focus Areas for future Integrated Water Management Plans (IWMPs)
- c. provide additional data you think we should consider
- d. comment on whether or not the IWMP Framework information (a CBRT post-2015 BIP project) is still applicable for future IWMPs

4. IPP List / Projects Database

March 31 is our deadline to get information about identified projects and processes (IPPs) into the BIP Update report. Anything you can provide by that date will be incorporated into the Projects database included in the BIP Update Report, and will be included in statistics and discussions in the report. Anything we receive after that date will get added to the Projects database for posterity, but won't be summarized or discussed in the report.

Colorado Basin Roundtable Meetings for 2021

The Colorado Basin Roundtable, along with eight other Basin Roundtables and the Interbasin Compact Committee (IBCC) were created by the Colorado Legislature "TO FACILITATE CONTINUED DISCUSSIONS WITHIN AND BETWEEN BASINS ON WATER MANAGEMENT ISSUES, AND TO ENCOURAGE LOCALLY DRIVEN COLLABORATIVE SOLUTIONS TO WATER SUPPLY CHALLENGES..." The Basin Roundtables were instrumental in development of the recently adopted Colorado Water Plan and will play a key role in the Plan's implementation.

The general public and other interested "stakeholders" are invited and encouraged to attend Roundtable meetings and actively participate in the Colorado Basin Roundtable process.
