Our firm is legal counsel to the Big Thompson Ditch And Manufacturing Company. We received your March 8, 2021 correspondence that enclosed the original documents relative to the agreement between the Big Thompson Ditch And Manufacturing Company and the Colorado Water Conservation Board.

Unfortunately, the "Quit Claim Deed" that released the lien on the assets of the Ditch Company erroneously named the grantee. I have enclosed a copy of the recorded "Quit Claim Deed" that you sent and a copy of the actual recorded version of that deed. The form of the "Quit Claim Deed" does not conform to the statutory Quitclaim Deed provided in Section 38-30-113, C.R.S.
