 - 2021 Grant Cycle 1 Submissions Update (5 min.) There may be additional money being added to the accounts in the WSRF fund. The initial 1-page form review is overall positive. The information that came in was helpful for discussions. Received feedback from an applicant asking for the ability to review prior to submitting. We will offer a review template in the future.

- 7. Water Shortage Preparedness and Coordination (Jason Finehout, Denver Water) (15 min.)
 Reviewed snowpack graphs in watersheds and discussed reservoir storage. Compared 2003 vs 2021 snowstorms. 2021 eased drought for plains, not as much for the front range. There is still a drought in many parts of the state. This is being communicated along with measures that can be implemented for drought preparedness using Denver Water Shortage Response Implementation Plan to message around the state. Reviewed water shortage restriction history. Presentation available by request.

8. Watershed Health and Fire Response / Post-Fire Recovery Playbook (Christina Burri, Denver Water) (30 min.)

Denver Water's (DW) three watershed values are drinking water treatability, infrastructure protection, and community and environmental stewardship. Presented south collection system priorities. Wildfire risk reduction is a key priority. Several fires started in the south collection system in 2020. There has been success with suppression efforts in treated areas. Forest to Faucets partnership between DW and USFS is key in being proactive in forest treatments. Post-fire playbook has been put together as guidance to be used around the state and provides information on what to do if fire occurs. DW is using the playbook to refine the guidance specific to DW needs. Presentation available by request.
